UN SYMBOLE POUR L'ASSOCIATION

Vous avez probablement remarqué que notre Bulletin a un nouvel emballage. Il affiche depuis quelques mois l'emblème et les couleurs de notre Association. En effet, le Bureau de direction a décidé de doter l'Association d'un insigne dans l'espoir de donner à nos documents un caractère distinctif et ainsi assurer à notre Association une meilleure présence.

Nous avons eu recours à M. Maurice Clayton un architecte à la retraite pour dessiner notre cachet. L'objectif de M. Clayton était de nous proposer un signe à la fois représentatif et attrayant. Nous pensons qu'il a largement atteint son but. Qu'en pensez-vous? Voici comment il faut le voir.

1^e Les caractères. Le symbole de l'Association est constitué des lettres P et S agencées de telle sorte qu'elles puissent être "lues" aussi bien en anglais qu'en français.

Les lettres elle-mêmes, S et P sont tirées d'incunables de la Bible du XIII^e siècle, reflétant la longue histoire de notre discipline et apportant un élément de prestige et de distinction à notre emblème.

Les chiffres au centre MCMXIII marquent l'année de fondation de notre organisme et étant en caractères romains, ils rattachent notre profession à un passé encore plus lointain et plus riche.

2^e Les couleurs. Les couleurs de l'Association sont donc sépia et sur beige. Sépia est une ancienne et noble couleur trouvée également dans les manuscrits bibliques. Ce sont deux couleurs mêlées qui symbolisent l'équilibre, la maturité et la maîtrise propres à une discipline scientifique.

3^e Le symbolisme. Notre cachet épouse la forme d'un cercle. Le cercle représente depuis fort longtemps la perfection et partout la vérité, quête par excellence de la science. Le cercle tient également pour le monde indiquant ainsi le vaste champ de la science politique.

Notre signe s'inspire en outre d'une fleur, le chrysanthème, la fleur politique par excellence, représentant le pouvoir, tant en Orient, qu'en Occident. Elle est l'emblème du "Souverain céleste" nippon et du Japon lui-même (le drapeau affiche le chrysanthème contrairement à ce que l'on croit normalement) et rappelons-nous d'une phrase célèbre dans l'histoire constitutionnelle occidentale au sujet de la place de l'inauguration des chrysanthèmes dans les pouvoirs d'un chef d'Etat.

La fleur tient aussi pour la poésie, qui n'est pas, du moins espérons-le, toujours étrangère à nos travaux.

COMMITTEES OF CPSA

The Board of Directors adopted in principle two reports submitted to it on December 6, 1986 by the Membership Committee and by the Women's Caucus.

The Membership Committee (made up of Henry J. Jacek, Chair, Martha Fletcher, David Hoffman, Gernot Köhler, John McDonough and Simon McInnes) studied the participation of non-academic political scientists in our Association. The Committee is of the view that efforts should be made to get non-university-based political scientists more involved in CPSA activities. Among the measures proposed and implemented by the Board are the creation of a section of direct interest to non-university based political scientists at our Annual Meeting and the nomination of non-academic political scientists to the Board of Directors. The Committee also proposed the creation of regional political science chapters comprising both university and non-university based political scientists. It could perhaps be mentioned that there are now proposals in the Ottawa-Hull area for the creation of such a group.

The Women's Caucus reminded the Board of the still difficult position of women in the Canadian political science profession (they are "relatively few".... "poorly paid"... and "clustering in part-time and contractually-limited positions"...) and proposed a "plan of action" which was discussed at the Chairpersons' Meeting (March 13-14, 1987) and which will be presented at the next Annual General Meeting in Hamilton on June 7, 1987. The Board having endorsed the "plan of action" in principle acted on the proposal directly related to the Association: that is to "actively seek out" ways to improve the participation of women in all CPSA activities.

Appointments:

We are pleased to announce the appointment of a new Editorial Board for our Journal: Ronald Manzer (Toronto), co-editor; Sylvia Bashevkin (Toronto), assistant editor; William Coleman (McMaster), review editor; Lucille Beaudry (UQAM), co-directrice and Stéphane Dion (Montréal), secrétaire à la rédaction et responsable des recensions. We wish good luck to the new Editorial Board and we take this opportunity to express our gratitude to the outgoing Board: Robert Boardman, Herman Bakvis, Grace Skogstad, François-Pierre Gingras and Lucille Beaudry.

Reginald Whitaker (York) is our new representative on the Advisory Council on Records of the Public Archives of Canada. Professor Whitaker has a deep interest in

questions related to the Public Archives and he wrote recently our brief on Bill C-7 Archives of Canada Act. We wish him luck and we thank warmly Donald C. Rowat (Carleton) for sitting several years on the Advisory Council.

Chairpersons' Meeting:

The Chairpersons met on March 13th and 14th at the University of British Columbia. This is a yearly meeting organized by the Association and it gives the chairpersons the opportunity to discuss various questions related to our discipline and to the life of our departments, such as, for example, budgetary restraints, the participation of women in our profession, etc. The meeting is more oriented to an exchange of views than to coming up with specific decisions. There were 35 participants at the Vancouver Meeting. The next one will be held at Dalhousie. Thanks are expressed to the host University, to the members of the UBC Department and to its Chair, David J. Elkins, for organizing such a warm meeting.

DAVID J. ELKINS, Professor and Chairman, Department of Political Science, University of British Columbia; also taught at University of California, Berkeley, and at Queen's; Visiting Fellow, Australian National University; author or co-author of four books and several articles in the Canadian Journal of Political Science and other journals; research interests include comparative politics (Canada, United States, Australia), political culture, parties and elections; extensive involvement in Canada Council and SSHRCC including Chair of Research Grants Adjudication Committee for Political Science and Law (1981-83); active involvement in CPSA, including Vice-Chair of Program Committee (1973), Board of Directors (1972-74), Constitutional Revision Committee (1972-77), and Nominating Committee (1975-76).

ANDRE BLAIS, professeur agrégé, département de science politique, Université de Montréal. Champs de recherche: analyse des politiques, élections. DAVID M. CAMERON is professor of Political Science, Dalhousie University. He holds a B.A. from Queen's and M.A., Phil.M. and Ph.D. degrees from Toronto. He has been at Dalhousie since 1969, spending two years, 1971-73, with the Ministry of State for Urban Affairs in Ottawa, and recently returned to teaching and research following appointment as Vice-President (Planning & Resources). Publications include Schools for Ontario, Federalism and Policy Development with J.S. Dupré, and numerous book chapters and articles on local government, education, regionalism and intergovernmental relations.

HUGH DONALD FORBES, Associate Professor, University of Toronto. Degrees: B.A. Honours, Manitoba; M.A. and Ph.D., Yale. Teaching and research in Canadian politics, political psychology, and the philosophy of science. Publications : Canadian Political Thought (edited), Nationalism, Ethnocentrism, and Personality, and articles in The Canadian Journal of Political Science, American Political Science Review, and Canadian Review of Studies in Nationalism

ANNE LEGARE, directrice du département de science politique de l'UQAM; Secrétaire-trésorière de la Société québécoise de science politique (1978-1980); directrice des études avancées (1979-1981). Auteur, entre autres: Le Québec: la question nationale, Paris, Maspéro, en 1979; un ouvrage à paraître à l'automne 1987 chez Hurtubise en collaboration avec Nicole Morf (le titre provisoire La pensée, le pouvoir et l'Etat, Québec-Canada 1930-1980). Ses domaines de recherche sont l'Etat et les pouvoirs régionaux, la théorie politique, la pensée féministe et les questions culturelles. Dans ces domaines elle a publié de nombreux articles dont: "Prospective de la spécificité Québec-Canada" in Socio Cultural Development Alternative in a Changing World, Tokyo, Université des Nations-Unies, 1982; "Régions, Nation et Etat dans la formation de nouveaux pouvoirs" dans La gauche, le pouvoir, le socialisme (ff. la direction de C. Buci Glucksmann), Paris, p.u.f.; "Mouvement féministe en Occident" in Emergence of a New Social Thought, Tokyo, Université des Nations-Unies, 1984; "Toward a Marxist Theory of Canadian Federalism" in Studies in Political Economy, Ottawa, no. 8, 1982; "Quelques courants dominant l'analyse de la région" en France et propos sur la définition de la région en France et propos sur la définition de la région." dans La décentralisation pourquoi faire, Cahier de recherche sociologique, Département de sociologie de l'UQAM, vol. 3, no. 1, avril 1985. Elle a également présenté des communications dans des colloques internationaux aux Etats-Unis, en France, en Italie, en Espagne, en Angleterre, en Inde et au Brésil. Ces travaux actuels sont en philosophie politique.

SIMON McINNES is Director, Corporate Planning and Coordination, Ministry of State for Science and Technology, Government of Canada. He was educated at Bishop's (BA 1970), McMaster (MA 1971), and Carleton (Ph.D. 1978). He taught at Saskatchewan (1974-75), Glendon College, York University (1975-77), and McMaster (1977-79). From 1979 to 1981 he worked as a constitutional advisor to the Inuit Committee on National Issues, working on securing the recognition of aboriginal rights in Canada's Constitution. In 1982 he joined Energy, Mines and Resources as an advisor on northern energy issues and became Chief, Federal- Provincial-Territorial Energy Relations in December 1983. He has been in his present position since August 1985.

Dr. McInnes has co-edited The Soviet Union and East Europe into the 80s (Mosaic Press, 1978); published articles in Canadian

Public Administration, Journal of Canadian Studies, Canadian Slavonic Papers, CA Magazine; contributed articles to several edited books; given over a dozen conference papers; published many reviews, and refereed for Methuen, Prentice-Hall, Canadian Public Administration and Canadian Public Policy. He has been a member of the CPSA Programme Committee for the 1978 and 1987 meetings. His current interests include Canadian science and technology policy, public administration and public policy.

J. PETER MEEKISON is Vice-President (Academic) and Professor of Political Science at the University of Alberta where he has been on staff since 1967.

Between 1974 and 1984 he served as Deputy Minister, Alberta Federal and Intergovernmental Affairs, where he developed and prepared the formula which ultimately became the amending formula in the Constitution Act, 1982. Previously, at the University of Alberta, he served as Chairman of the Department of Political Science and Associate Dean of Graduate Studies. His basic teaching and research interests are in the area of Canadian government and politics, specializing in the Canadian federal system.

He is a member of Phi Beta Kappa, was a recipient of the Queen's Jubilee Medal, is an Officer of the Order of Canada, and was on the CPSA Board from 1972 to 1974.

J.M. PORTER is a Professor of Political Studies at the University of Saskatchewan, Saskatoon. He holds degrees from Park College (B.A.) 1959, University of Wyoming (1960), Duke University (1967). He has edited Martin Luther: Selected Political Writings (1974), Sophia and Praxis: The Boundaries of Politics (1984), with Richard Vernon, Unity, Plurality and Politics: Essays in Honour of F.M. Barnard (1986), Classics in Political Philosophy (1987, forthcoming) and has published articles in Marxist Perspectives, The American Journal of Jurisprudence, The Journal of the History of Ideas, and elsewhere. He has been the section head for the Political Philosophy section in 1979 and 1986, and Program Chairman in 1980.

CAROLYN TUOHY is Associate Professor, Department of Political Science, University of Toronto. She received her B.A. from the University of Toronto and her M.A. and Ph.D. from Yale University. Her research interests are in the area of social policy, particularly health policy and social regulation. She has published articles on medical politics, professional regulation and occupational health regulation, in journals such as The Canadian Journal of Political Science, Canadian Public Policy, Law and Policy, and The Osgoode Hall Law Journal; and is co-author of Opting Out of Medicare: Private Medical Markets in Ontario (1980). She has served as a member of the editorial board of Canadian Public Administration and as Public Policy / Public Administration section head for the CPSA program committee (1984).

STEVEN B. WOLINETZ is associate professor of Political Science at Memorial University of Newfoundland. He is a specialist in comparative and Western European politics with research interests in the smaller democracies and particularly the Netherlands. Current research includes an edited volume on contemporary party systems and a larger project on changing relationships among trade unions, business, and government in the Netherlands. He has taught at Memorial since 1971 and was Head of the department from 1978-1981.
