ANDRE-J. BELANGER, Professeur au Département de science politique de l'Université de Montréal depuis 1973. A également enseigné à l'Université Laval (1965-73) ainsi qu'à McGill, à l'Université d'Ottawa et à l'École nationale d'administration publique.
Publications: Framework for a Political Sociology (1985), Ruptures et constantes: Quatre idéologies du Québec en éclatement (1977) et L'apolitisme des idéologies québécoises, le grand tournant de 1934-1936 (1974). Membre du bureau de direction de l'Association canadienne de science politique: 1972-74 et 1986-88, et de la Société québécoise de science politique 1972-73 et 1982-84. Champ d'intérêt actuel: le phénomène de la représentation comme relation publique.

EDMUND A. AUNGER, Professeur agrégé de science politique et directeur du Secteur arts et sciences, Faculté Saint-Jean, University of Alberta. Degrees: B.A. (Wilfrid Laurier), M.Sc. (London), Ph.D. (California). Teaching and research in Canadian and Comparative Politics. Publications include In Search of Political Stability (McGill-Queen's University Press, 1981) and various articles and book chapters on political violence, social class and language policy. Area specializations: Northern Ireland, New Brunswick and Belgium. Awarded 1980 Samuel H. Beer Prize in British Politics. Member, 1986 CPSA Programme Committee: Convenor, Comparative Politics (Western)

ANDREW FENTON COOPER, Assistant Professor, Department of Political Science, University of Waterloo; Associate Director, Centre on Foreign Policy and Federalism, University of Waterloo/Wilfrid Laurier University. D.Phil in Politics, University of Oxford, 1980. Areas of specialization include Comparative Politics (Western), Comparative Public Policy, and International Political Economy. Editor of several collections of Conference proceedings, including Canadian Culture: International Dimensions (Canadian Institute of International Affairs, 1985). Author of The Transformation of British Agricultural Policy: A Study in Conservative Politics (University of Manchester Press, forthcoming). Has contributed articles to International Journal, Etudes internationales, Agricultural History and Journal of European Integration. Visiting Scholar, Center for International Affairs, Harvard University, 1986-87.

MAUREEN COVELL received her BA from the University of British Columbia, and her MA and Ph.D. from Yale University. She has been teaching at Simon Fraser since 1977, having also taught (in Canada) at the University of Victoria and Windsor University. Her research interests include African Marxist regimes and comparative federalism. Publications include Madagascar: Politics, Economics, Society, and several articles on regionalization in Belgium with comparisons to Canada, that have appeared in the Canadian Journal of Political Science, West European Politics, and several edited volumes. She has chaired the International conferences and Nominating committees of the Canadian Political Science Association, and is on the Board of Directors of the Comparative Federalism Research Group of the International Political Science Association.

AUDREY DOERR, currently holds the position of Director General, Federal Research Branch, Ministry of State for Science and Technology. She has also worked in the Department of Indian Affairs and Northern Development, the Privy Council Office and the Ministry of State for Urban Affairs at different times from 1972. From 1977-83, she was Associate Professor, Department of Political Science, Simon Fraser University where she also served as Chairman of the Department and Associate Dean of Graduate Studies during different periods. From 1970-72, she was Assistant Professor, Department of Political Science, University of Lethbridge. She holds M.A. (Public Administration) and Ph.D. (Political Science) degrees from Carleton University and B.A. (Political Science) degree from the University of Saskatchewan. She is the author of Machinery of Government in Canada as well as numerous articles on public policy and public administration in Canada. Her most recent publication is the chapter on 'Canada' in D.C. Rowat's, Public Administration in Developed Democracies: A Comparative Study, (1988). She is a member of the Institute of Public Administration, Canadian Political Science Association and the Association of Canadian Studies.

ELISABETH GIDENGIL is an assistant professor in the Department of Political Science at McGill University. She received her BA from the London School of Economics, MA from New York University, and Ph.D. from McGill. Her teaching and research interests are in the areas of Canadian voting and political economy with a particular interest in regionalism. She is Political Sociology and Behaviour Section head for the 1988 CPSA Programme Committee.

GUY LACHAPELLE was born in Montréal on January 14th 1955. He received his Bachelor's Degree and his Master's Degree in Political Science from the Université de Montréal. He also earned an MA Degree and a Ph.D. Degree from Northwestern University (Illinois). He participated in the publication of Québec: Un pays incertain, (1980) and recently in Le système politique des Etats-Unis (Edmond Orban, ed., 1987). He has also published several articles which appeared in the Canadian Journal of Political Science, Politique, and the newspaper, Le Devoir. Since 1984, he has been an Assistant Professor of Political Science at Concordia University (Montréal) teaching in the MA Programme in Public Policy and Public Administration. His research interests are Social/Welfare Policy, Voting Behaviour, Political Communication and U.S. Politics.

THOMAS J. LEWIS is an Associate Professor in Political Science at McMaster University. He teaches and writes in Classical Greek thought, European natural right theory of the 17th and 18th centuries, and the development of liberal political economy. He also writes on the application of natural right concepts to contemporary legal and public policy issues. He participates regularly in the CPSA Meetings, and headed the political theory section in 1984. His work has been published in: Canadian Journal of Political Science, Interpretation, Canadian Journal of Economics, Journal of Economic Issues, American Behavioural Scientist, and the Osgoode Hall Law Review.

ROBERT C. PAEHLKE (BA., Lehigh; MA, New School; Ph.D., U.B.C. (1974)); Professor, Trent University; Chairman, Political Studies Department (1982-1985); Member, Council of Ontario Universities (1983-1985); currently: member Board of Directors, Social Science Federation of Canada, National Advisory Board, Canadian Environmental Defense Fund. Research interests: environmental policy, occupational health policy, energy policy, regulation, socio-political movements. Founding editor, Alternatives: Perspectives on Society and Environment. (1971-1982). Selected Publications: A Center Which Holds: Environmentalism and the Restoration of Progressive Politics (New Haven: Yale University Press, 1988); articles in: Canadian Public Policy, Studies in Political Economy, Sociologie et Société, Environmental Ethics, Policy Options, Environment, etc. Consulting/public education activities: Science Council of Canada, Canadian Labour Congress, UAW (Detroit), YMCA (Toronto), CBC Radio (Radio Noon, Ideas), TV Ontario.

DOUGLAS E. WILLIAMS was educated at California State University, Stanford University, the University of Essex, and received his Ph.D. from the University of British Columbia. He has taught at Vancouver Community College, Capilano Community College, the University of Victoria, Queen's University, and McGill University, where he held a Social Sciences and Humanities Research Council of Canada Postdoctoral Fellowship in Political Theory. Recently he was awarded a Canada Research Fellowship in the Department of Political Studies at Queen's, where he is completing a book on postwar political theory, The Voices of Political Theory in the Conversations of Our Times. His publications include Truth, Hope, and Power: The Thought of Karl Popper (University of Toronto Press, 1988), editor of Constitutionalism, Government, and Society in Canada: Selected Essays by Alan C. Cairns (McClelland and Stewart, Ltd., 1988), and a number of articles and reviews on the philosophy of the social sciences, the development of Political Science in Canada, and contemporary political theory and cultural criticism.

A.J. WILSON, Department of Political Science, University of New Brunswick was Chairman of the department for 4 successive terms, 1972-86. Ph.D. LSE and D.Sc. (Econ.) University of London, Professor Wilson held the Foundation Chair in Political Science at the University of Peradeniya before joining the University of New Brunswick. Over his long career, he has remained advisor to the government of Sri Lanka, for example in the framing of the current Constitution. Having held Research Fellowships (e.g. London School of Economics, McGill, Columbia and Oxford Universities) over the years, Professor Wilson has been the author of 4 books published in the U.K. and co-editor of two collections of scholarly readings. He has contributed articles and chapters to books and journals published in Britain, The United States and Japan. He is currently on the Editorial Board of The Round Table: A Journal of Commonwealth Affairs and previously served on the Editorial Board of The Journal of Commonwealth and Comparative Politics.

NEWS FROM THE SSFC/ INFORMATION DE LA FCSS

This first Column for 1988 will deal mainly with the Federation's lobbying activities and with news from the Social Sciences and Humanities Research Council. In the interest of time and space, I will be very brief. Do not hesitate to contact me for additional information, either by phone or by electronic mail (Netnorth/Bitnet, SSFC@UOTTAWA).

Funding of R&D. As expected, the Prime Minister used the Conference on Technology and Innovation to announce federal funding of \$1.3 billion for new science and technology initiatives over the next five years. While the precise use to be made of these sums of money is not entirely clear, it would appear that some \$250 million will be devoted to a program of Centres of Excellence and several million to the creation of undergraduate scholarships in science and engineering. The balance, that is to say a sum of \$1 billion, will be allocated following consultations with various Ministers. Needless to say, the Social Science Federation of Canada will make strong representations on at least two aspects of this recent announcement: first of all, we will stress the fact that the social sciences are very much absent from the initiatives just announced, and that the government is thereby defeating its objective which is to increase Canada's competitiveness in international markets. The problems facing our economy are not only of a technological nature: they relate at least as much to the diffusion of the new technologies, their management and their acceptance by society. These are social science issues. The Federation will also make representation to government that a significant proportion of the yet unallocated \$1 Billion should be given to the Social Sciences and Humanities Research Council.

Statistics Canada. The Federation's representations for a greater accessibility of Statistics Canada data will soon produce concrete results. We learned recently that university researchers will be offered a 70% discount on Statistics Canada's publications. You will remember that, following drastic cuts in this agency's budget, the price of publications has skyrocketed. This 70% discount, available to university researchers only, will bring the prices back to more sensible levels. In addition, the government is giving serious consideration to modifying the Depository Libraries Program, so as to include machine-readable products. All university libraries are considered as Depository Libraries and therefore have access to Statistics Canada products free of charge.

National Science Policy. The Federation has submitted a Brief to the Working Group on Basic Research established by the Council of Ministers of Science and Technology. This Group is one of seven Working Groups charged with developing an action plan for the national science policy. The Federation's Brief illustrates the way in which the social sciences can make a crucial contribution to the implementation of a national science policy. Copies of the Brief are available from the Secretariat.

Financement de la R&D. Lors de la Conférence nationale sur la Science et la Technologie, tenue à Toronto du 13 au 15 janvier et présidée par le Premier Ministre, le gouvernement a mis fin à quelques mois de "suspense" en annonçant qu'une somme de 1.3 milliards de dollars serait attribuée, au cours des cinq prochaines années, à la R&D au Canada. On ne sait pas encore de façon précise comment ces sommes seront utilisées: il semble clair qu'environ 250 millions de dollars seront consacrés à la mise sur pied de Centres d'excellence (très vraisemblablement en sciences naturelles et en génie uniquement), que quelques dizaines de millions seront consacrés à un programme de bourses de premier cycle en sciences naturelles et en génie, mais l'utilisation du milliard de dollars restant est encore indéterminée. Il va sans dire que la Fédération va faire des représentations sur au moins deux aspects de ces récentes annonces: tout d'abord, nous allons souligner l'absence totale des sciences sociales dans les initiatives annoncées jusqu'à présent, et attirer l'attention du gouvernement sur le fait qu'en négligeant totalement les sciences humaines, il s'expose à manquer complètement la cible qu'il s'est donnée, à savoir d'augmenter la compétitivité du Canada sur les marchés internationaux. Les problèmes auxquels le pays fait face ne sont pas seulement de nature technologique, mais relèvent beaucoup plus de l'ordre de la diffusion des technologies, de leur gestion et de leur acceptation sociale. Ce sont là des questions qui concernent les sciences sociales au premier chef. Par ailleurs, la Fédération va faire pression pour qu'une proportion importante du milliard de dollars non encore alloué soit accordée au Conseil de Recherches en Sciences Humaines.

Statistique Canada. Les efforts de la Fédération en faveur d'une plus grande accessibilité des données de Statistique Canada vont enfin porter fruit: de source sûre, nous avons appris que le gouvernement va réduire de 70%, pour la clientèle universitaire seulement, le prix des publications sur support papier de Statistique Canada. On sait que, suite aux coupures effectuées dans le budget de cette agence fédérale, les prix des publications avaient connu des hausses exorbitantes. Autre bonne nouvelle: le gouvernement s'apprêterait à élargir le programme des Bibliothèques de dépôt, afin d'inclure les produits ordinolingués parmi la liste des produits disponibles gratuitement. Toutes les bibliothèques universitaires font partie du réseau des Bibliothèques de dépôt.

Politique scientifique nationale. La Fédération a soumis au Groupe de travail sur la recherche fondamentale formé par le Conseil des Ministres de la Science et de la Technologie un mémoire soulignant l'importance de la recherche fondamentale en sciences sociales dans la mise en oeuvre de la politique scientifique. Le Mémoire est disponible au Secrétariat de la Fédération.

Copyright Act. The first series of amendments to the 1924 Copyright Act will shortly receive third reading. This first series dealt mainly with the rights of creators, and it leaves unanswered many questions related to users' rights. The Minister of Communications will bring forward, in April, a second set of amendments which, it is hoped, will adequately cover the rights of users of copyright materials. Needless to say, the Federation will monitor this dossier very closely.

News from the Social Sciences and Humanities Research Council. William E. Taylor stepped down as President, on December 31, 1987. The Secretary of State has appointed John Leyerle as acting President, while the search for a new President continues. Ericka Bruce, former Director General, Programs Branch, resigned last September. She has been replaced by Ralph Heintzman, who took up his post on October 26. On a different subject: at a special meeting to be held on January 29, 1988, the SSHRCC will consider the recommendations submitted by its sub-committee on priorities. This sub-committee is chaired by Gilles Paquet.

A new Federation member. The Social Science Federation of Canada is pleased to welcome as its 24th constituent member the Canadian Indian/Native Studies Association.

Social Science Magazine. At its January 16 meeting, the Board of Directors of the Federation decided to abandon the project of a Federation-sponsored social science Magazine. This Magazine would have popularized the results of social science research to a wide audience.

Loi sur le droit d'auteur. On peut considérer qu'à toutes fins pratiques, la première série d'amendements à la Loi sur le droit d'auteur est maintenant adoptée. Ces amendements contiennent encore bien des aspects insatisfaisants, du point de vue des utilisateurs. La Ministre nous promet, pour le mois d'avril, une deuxième série d'amendements qui, espérons-le, tiendront compte des droits des utilisateurs des oeuvres couvertes par le droit d'auteur. La Fédération continuera à suivre ce dossier de près.

Nouvelles du Conseil de Recherches en Sciences Humaines. Quelques nouvelles brèves: William Taylor a quitté son poste de Président le 31 décembre. Ses fonctions sont occupées, par interim, par John Leyerle, le doyen des membres du Conseil. Le gouvernement poursuit ses recherches en vue de combler la Présidence. Par ailleurs, le Conseil a maintenant un nouveau Directeur général des Programmes en la personne de Ralph Heintzman, depuis le 26 octobre 1987. Il remplace Ericka Bruce, qui a quitté le Conseil le 24 septembre. Dans un autre ordre d'idées, le Conseil étudiera, lors d'une réunion spéciale prévue pour le 29 janvier, le Rapport du Groupe de Travail sur les Priorités, présidé par Gilles Paquet.

1989 - André Laurendeau, Homme politique, dirigeant du Bloc populaire, journaliste et écrivain, co-président de la Commission royale d'enquête sur le bilinguisme et le biculturalisme au Canada.

1990 - Daniel Johnson, Chef du Parti de l'Union Nationale (1961-1968) et Premier ministre du Québec (1966-1968).
