This issue of the *Bulletin* launches a (somewhat) new format that members of the Association might notice. No longer will the minutes of the AGM, the various annual reports, and the financial report of the CPSA be published in the *Bulletin*; rather, these will be posted on the Association's Web page. Equally, the section "In the Journals", which has been a cornerstone of the *Bulletin* for many years has been suspended, again as a reflection of the fact that many of the Tables of Contents of current issues of academic journals are easily available on the Internet.

The Internet has also meant, however, that the *Bulletin* has become a forum for greater exchanges between Departments of Political Science across the country. Increasingly the pages of the *Bulletin* are filled with news coming from our colleagues. As such, the advent of new information technologies has made it easier for the *Bulletin* to fill one of its most important functions -- to keep political scientists across the country up-to-date with the activities ongoing in other Departments. As editors, we thank our colleagues for their willingness to send us their news; the *Bulletin* is a richer medium for exchange as a result of the participation of all the members of the CPSA.

**FROM THE PRESIDENT/ LE MOT DU
PRESIDENT**

Je suis heureux de vous signaler que tout va très bien à l'Association canadienne de science politique. L'association demeure en bonne posture financière et le nombre de ses membres reste stable en dépit des compressions continues dans bon nombre d'universités et de milieux de recherche.

Notre Programme de stages parlementaires a un nouveau directeur en la personne du Pr Leslie Pal. Je sais que vous vous joignez tous à moi pour lui souhaiter tout le succès voulu. Le Pr Pal met en place une nouvelle structure de direction qui a été élaborée par un comité spécial de l'ACSP et approuvée par le conseil d'administration. Le Pr Robert Williams continue d'assumer la direction du Programme de stages à l'Assemblée législative de l'Ontario; je suis convaincu qu'il pourra compter sur votre fidèle appui. Je tiens à profiter de l'occasion pour vous rappeler d'encourager les étudiants et étudiantes à poser leur candidature pour ces programmes.

Le mandat de l'équipe éditoriale anglophone de la Revue canadienne de science politique se termine en juin 1999. Un comité de recherche, présidé par la Pr Sylvia Bashevkin, a été mis sur pied afin de recommander une nouvelle équipe au conseil d'administration qui se réunira en novembre 1998.

Je tiens à remercier sincèrement, au nom de l'association, l'équipe actuelle pour son enthousiasme et son excellent travail.

J'aimerais maintenant reprendre quelques-unes des questions qui ont été soulevées lors de notre dernière assemblée générale annuelle. Premier point: il a été proposé que «le procès-verbal de l'assemblée générale annuelle et les rapports financiers qui sont normalement publiés dans le numéro de mai du Bulletin fassent partie du site Web chaque année et qu'une copie des documents soit distribuée aux directeurs et directrices de département». Cette proposition a été adoptée et mise en place. Deuxième point: j'ai pris l'initiative

d'écrire aux commanditaires des prix Smiley et Macpherson afin de leur demander que les prix soient décernés chaque année plutôt qu'aux deux ans. J'attends leur réponse. Troisième point: j'ai signalé lors de la réunion du conseil d'administration du 2 juin 1998 qu'au cours de l'assemblée générale annuelle, le Caucus des femmes s'est dit insatisfait du manque de réaction apparent du conseil au Rapport sur la condition des femmes et à ses recommandations. Le rapport a en fait beaucoup intéressé le conseil qui a discuté de ses recommandations et y a donné suite. Le malentendu est imputable à un problème de communication. Aussi, le conseil a-t-il demandé à la Pr Turenne Sjolander d'inclure les recommandations et la liste des départements qui n'ont pas répondu, ainsi que la section pertinente du procès-verbal de la réunion du conseil d'administration de décembre 1997, dans le numéro de mai du Bulletin. Les documents ont également été diffusés sur POLCAN et par la messagerie électronique du Caucus des femmes. Je vais aussi mettre la question à l'ordre du jour de la réunion des directeurs et directrices de département en 1999. Je suis heureux que cette question soit maintenant réglée.

La réunion des directeurs et des directrices de département aura lieu au campus of l'Université de Moncton les 30 et 31 janvier 1999. J'invite les directeurs et directrices à me faire parvenir, dès que possible, les sujets qu'ils aimeraient voir abordés.

La planification du Congrès mondial de l'AISP en l'an 2000 progresse. Plusieurs personnes qui ont participé à notre dernière assemblée générale annuelle se sont dites inquiètes des engagements et obligations de nature financière de l'ACSP, hôte conjoint du congrès. Le conseil d'administration est en train de mettre en place des mesures en vue de déterminer et de limiter les obligations financières de l'ACSP à cet égard.

Je tiens à vous rappeler que l'assemblée générale annuelle 1999 aura lieu à l'Université de Sherbrooke du 6 au 8 juin. Le Pr Alain Noël et son comité de programme sont en train de planifier une

Pour le prix de 1999, la thèse doit avoir été rédigée et défendue en 1997 ou en 1998.

En terminant, je tiens à vous informer que nous avons changé d'adresse. Nous sommes en effet maintenant installés au bureau 204, 260, rue Dalhousie, Ottawa, ON K1N 7E4. Michelle Hopkins, toujours aussi professionnelle, a organisé le déménagement de main de maître. Je tiens à la remercier vivement de toute l'aide qu'elle m'a apportée au cours de ces derniers mois et de l'excellente façon dont elle sert les membres.

I am happy to report that things are going very well at the Canadian Political Science Association. The Association remains in good financial health and our membership is stable, despite continued cutbacks in a number of universities and research communities

We have a new Parliamentary Internship Programme director. Professor Leslie Pal has agreed to take over, and I know that you will join me in wishing him well. Professor Pal is implementing a new governance structure developed by a CPSA special committee and approved by the Board. Professor Robert Williams carries on as OLIP director, and I have no doubt that he can count on your continued support. I would like to take advantage of this opportunity to remind you to

encourage students to apply to the programmes.

The term of the current English-language editorial team of the Canadian Journal of Political Science ends in June 1999. We have a search committee in place, chaired by Professor Sylvia Bashevkin, to recommend a new team at the November 1998 Board of Directors meeting. I would like to express on behalf of the Association a sincere thank you to the current team for their hard work and dedication.

There are several issues from our last Annual General Meeting that I would like to highlight. First, a motion was proposed that "the Annual General Meeting minutes and the financial reports normally published in the May issue of the Bulletin be posted on the web every year and that a paper copy of the documents be distributed to the Chair of Departments." This motion was carried and has been implemented. Second, I undertook to write to the sponsors of the Smiley and Macpherson prizes to request that the awards be granted annually rather than on a biennial basis. I have done this and we are waiting for a response. Third, I reported to the Board of Directors meeting of June 2, 1998 that there was dissatisfaction expressed at the Annual General Meeting by the Women's Caucus over the Board's apparent lack of reaction to the Status of Women Report and its recommendations. The Board has indeed expressed strong interest in the report and has discussed and acted on its recommendations. The misunderstanding resulted from a breakdown in communications. Accordingly, the Board asked Professor Turenne Sjolander to include the recommendations and list the names of non-respondent departments, together with the relevant Board of Directors minutes of December 1997, in the May issue of the Bulletin. The documents were also circulated on POLCAN and the Women's Caucus list server. I will also place the item on the 1999 chairs' agenda. I am pleased that this matter has now been cleared up.

The 1999 chairs' meeting will be held on the campus of l'Université de Moncton on January 30 and 31, 1999. I invite chairs to forward to me, as soon as possible, subjects they would like to discuss

at the meeting.

Planning for the IPSA World Congress in 2000 is progressing. A number of participants at our last Annual General Meeting expressed concern over CPSA's financial commitments and obligations in co-hosting the Congress. The Board of Directors is putting in place measures to determine and limit the Association's financial obligations in co-sponsoring the IPSA Congress.

I would like to remind you that the 1999 Annual Meeting will be held at the Université de Sherbrooke from 6 to 8 June. Professor Alain Noël and his program committee are planning an interesting set of sessions. It is not too early to remind members that CPSA will be holding its year 2000 conference jointly with SQSP at the Quebec City Congress Centre, July 29 to August 1.

There is one other important reminder. Chairs should remember to send their nominations for the Vincent Lemieux prize. The new prize will be awarded to the best doctoral thesis in any subfield of political science written in English or French and judged worthy of publication either as a book or a series of articles. For the 1999 award, a thesis must have been completed and defended in 1997 or 1998.

Finally, I want to inform you that we moved our office from #205 - 1 Stewart Street, Ottawa, ON K1N 6H7 to #204 - 260 Dalhousie Street, Ottawa, ON K1N 7E4. Michelle Hopkins, as in all things, managed the move with a minimum of administrative dislocation. I also want to express my sincere thanks to her for all the assistance she has given me in recent months and for her role in serving members so effectively.

The 70th CPSA annual meetings were held at the University of Ottawa as part of the first Congress of the Social Sciences and Humanities. The Congress was well attended and the quality of the

presentations was very good.

The 1998 Organizing Committee

The number and division of sections we adopted were the same as those used in the 1997 programme. Even though Law and Public Policy were kept as a single section, the section worked well. The number of proposals accepted made it impossible to only hold one session per time slot. Canadian Politics, International Relations and Law and Public Policy had two parallel sessions per time slot. There were only four time slots where no sessions were held. The work of the section head is central to the quality of the Programme. The 14 section heads have to be thanked for their hard work.

Format

The format adopted at Brock (1996) and mostly used at Memorial (1997) had to be modified. We received so many proposals in many sections that the format of one paper and one discussant per 50 minute session could not be kept as a general rule. We could not also follow the previous year's recommendation to eliminate the first morning session. In order to accommodate more paper-givers, some sections had to double up the first two sessions in the morning and the two sessions after the 10:20 break. The mix of one paper (50 minutes) and two or three papers (1h50) seems to have worked very well. The papers in the same session were always related which might have helped to ensure a larger audience. As for the afternoon, we continued the practice of holding two larger sessions that either featured multi-paper presentations, roundtables or workshops. We also had two plenary sessions, one held on Sunday evening on Social Justice and Redistribution and one held on Monday afternoon on Citizenship, Democracy and Diversity. Both sessions were attended by more than 150 people.

It seems that the format should be kept flexible in order to allow some sections to regroup related papers as long as there is no session overlapping the 10:20 break. This allows delegates to move from

one section to another. This flexible format also allows more good papers to be presented and reduces the number of parallel sessions, ensuring that the sessions are better attended. We received very positive comments on the fact that all the sessions in each section were kept in the same room for the entire conference. This made the scheduling problems easier and the delegates did not have to find their way all over the campus. The 1998 organizing committee found it difficult to restrict each section to one session at every time slot and one person per session. To follow that type of format would have forced the section head to reject more than half of the proposals with no real basis on which to do so. We strongly recommend that the CPSA Board leave as much flexibility as possible to the 1999 organizing committee concerning the structure of the sessions. The 50 minute - one paper session is an excellent format, however, and should be kept the main format for the morning sessions.

Attendance

600 delegates registered of which about one third were students.

Other sessions

Besides the two plenary sessions, the CPSA held joint sessions with different associations. For instance, we had 5 joint sessions with the Canadian Women's Studies Association. We also had 3 joint colloquia, one with the Canadian Urban Research Network on Urban Affairs, another with the Canadian Communication Association on *Nouvelles technologies d'information et de communication* and one with the Policy Research Secretariat (Federal Government) on the Policy Research Initiative and the Challenge/ Multidisciplinary Approaches.

Appui de l'Université d'Ottawa

L'Université d'Ottawa, la faculté des sciences sociales et le département de science politique nous ont appuyés financièrement. Ceci nous a permis d'avoir quatre conférenciers de l'extérieur et d'embaucher 4 étudiants pour s'occuper de

We also intend to be at the next APSA Annual Meeting in Atlanta next September.

We had a very stimulating and profitable meeting with Gilles Pronovost (Université du Québec Abitibi-Témiscamingue) and Bill Raimier (Concordia), co-chairs of the 14th International Sociology Congress which took place in Montreal last summer. We were able to identify several potential sources of funding and define the main constraints and difficulties that we will have to overcome in the coming months. In the sociologists' case, 100% of the registration fees went to organizing the Congress, while we will only receive 25% of these revenues. We will have to call

more on granting organizations and the private sector.

Finally, we are pleased to announce that students who wish to participate in the Congress will not have to pay registration fees and that the housing costs at the Laval campus are highly competitive. Tell your students. August 2000 is coming up fast...

**"Interrogating Globalization and the
 Importance of Subdiscipline Confluence"**

The air within and beyond the academy is full with buzz about globalization. It is said to the point of being clichéd that we 'live in an era of globalization', 'that globalization is inescapable'. One of the shibboleths of this mantra is that notions of domestic and foreign, national and international, are increasingly irrelevant.

The vast majority of scholars work within subdisciplines. While this is not necessarily lamentable, sometimes there is heuristic value in bringing vectors of inquiry together. To properly interrogate the phenomenon of globalization students of domestic and international politics must begin a dialogue that leaves the confines of their subdisciplines. One such confluence, and the subject of this article, is the study of the international activities of what are often called non-sovereign governments.

What follows is a brief overview of the development of this literature. From a Canadian perspective exploration of the international activities of provinces, or more generally on an international dimension to provincial affairs, belongs to three eras. From the early 1930's through the early 1960's it was highly legalistic and confined to the constitutional and international legal aspects of

provincial implementation of treaties. The second period in the literature, from the mid 1960's to the early 1970's, was initially largely legalistic in its approach and was preoccupied with the blurring of Canada's international personality as a result of invitations from 'La francophonie' for Quebec to participate in international conferences on education as a separate delegation from that of the government of Canada. The literature of the current or modern era has embraced the evacuation of legal/constitution considerations, that came to be evident toward the end of the preceding period, and has fully adopted a political science approach.

Literature of the modern period began with the premise that the international activities of provinces were a threat to the maintenance of the federation as they challenged the indivisible sovereignty of the central government. The origins of this view are, largely, threefold: the legacy inherited from, and fostered by, the legal perspective from which the literature of the modern era evolved; the international activities of the Province of Quebec which have at times been part of an 'independentist' project with the objective of obtaining recognition as a sovereign state; and the hegemonic state-centric paradigm which went largely unchallenged until Keohane and Nye's work in the early 1970's.(1) Increasingly throughout the current period observers have been moving away from this understanding until perhaps most effectively John Kincaid argues, in 1990, that not only should the international activities of constituent governments be seen as reasonable but also as highly desirable.(2)

Quebec's volition to participate externally originally set the tone, and much of the focus, of study.(3) In the mid 1980's the focus of a number of substantial publications began to broaden. The first, in 1984, was a special issue on the international activities of federated governments in *Publius: The Journal of Federalism*.(4) In 1986, the *International Journal* devoted an issue to foreign policy in federal states(5); and, in the same year Ivo Duchacek's seminal work *The Territorial Dimension of Politics, Within, Among, and Across Nations* was published.(6) In 1988, 1989, 1990 and 1993 edited

books appeared.(7) Notably, the scope of investigation was expanded by the volume published in 1989 which was devoted to the international activities of municipal governments; and not, as the others, to the international activities of federated governments.

As the special issues of the journals indicate, attention was coming from students of both federalism and international relations. The genius of the late Ivo Duchacek, who was both a student of federalism and of international relations, was that, in *The Territorial Dimension of Politics, Within, Among, and Across Nations*, he provides a conceptual synthesis drawn from these sub-disciplines.(8) As Daniel Elazar says, "[Duchacek made a] signal contribution to our understanding of how federalism and international relations are becoming increasingly linked." "He [took] the lead in ... studying this ... phenomenon, [and gave] us the terminology with which to describe it."(9).

Where in political science is the intellectual context for such investigation found? In part, it is located in the evolution of the study of international relations. The realist perspective holds that the international system is structured by the pursuit of national interest and maximization of power relative to other states. Issues are characterized as either the "high politics" of security and military issues or "low politics" understood to encompass economic, social and environmental questions. In this model the line between domestic and international is clearly delineated and the nation-state is seen as an impermeable, univocal, homogeneous monolith.

Increasingly this rather parsimonious explanation of international relations was found wanting. This representation with its "high politics" issue stratification and state centric analysis did not seem to be sufficiently complex to explain the reality of growing multi-issue, multi-centric interdependence. Moreover, nation-states were being observed not as coherent actors but rather seemed to exhibit many, often competing, points of international contact within themselves.(10) The realist model, like idealism before it, was of course state centric and

the emergence of a model that was not advanced only in 1972, when Keohane and Nye asked, "Is the state-centric view, which focuses on the interstate system, an adequate analytic framework for the investigation of contemporary reality?"(11).

Prior to Keohane and Nye's 'world politics paradigm' diverse domestic interests were seen to "... have effects on international politics only through governmental foreign policy channels.", and, "Intersocietal interactions [were] relegated to a category of secondary importance - the 'environment' of interstate politics."(12). Keohane and Nye elevated intersocietal interactions to the same level as interstate interactions.(13) In their "cobwebbed"(14) model there is contact between three types of interactions: transnational interactions consisting of "... the movement of tangible or intangible items across state boundaries when at least one actor is not an agent of a [central] government or an international organization."(15); transgovernmental interactions involving "... sets of direct interaction among sub-units of different [central] governments that are not controlled or closely guided by the policies of the cabinets or chief executives."; and finally, traditional, interstate interactions understood "... as official exchanges between representatives of national [central] governments."(16).

This contribution established the intellectual base upon which the study of non-sovereign government international activity is built. The introduction of the concept of 'transnational interactions' is important for such investigation because it presents new types of actors as legitimate participants in world politics. The term 'transgovernmental interactions' is significant because it recognizes that governments(17) interact with the global community not as one coherent actor but rather through numerous, and at times discordant, loci of contact. These two observations provide the conceptual basis and thus are of paramount importance.

However, while these actors and activities are understood within the paradigm of complex

interdependence and pluralism they are often mis-named through the application of the terminological lexicon of realism. The prevailing context for their study is the world politics paradigm and yet the inspiration of much of the terminology is drawn from a state-centric perspective.(18) There is a tendency, due to the development of the literature with its state-centric preoccupation, to perhaps unwittingly in some cases, use terms that accord superior status to nation states. Within the realist framework is the bias of fragmentation while pluralists see the activities of these governments in terms of legitimate segmentation. The bias of fragmentation is that these activities are illegitimate and have the effect of breaking the authority of the central government into pieces or fragments, and the temper of segmentation is that these activities are legitimate and reflect a trend towards the division of international activities into parts or segments. For example, the terms 'subnational' and 'substate governments' are found widely in the literature. Relative to other terms they imply potential nationhood and statehood if only the governments described could transcend their subordination. These two terms clearly fall within the framework of understanding elaborated as 'fragmentation.' The term 'coordinate government'(19) puts the emphasis on coordination and cooperation and belongs under the 'segmentation' banner. Other terms do not fall as fully under either rubric, however one does detect a subtle movement in appreciation from the fragmentation toward the segmentation perspective in terms such as: non-central government(20), federal subdivision(21), federated government(22), component government(23), and constituent government(24). While this is not the place to further elaborate upon this point, it is interesting to note that in the emergence of a new area of enquiry there is perhaps a tendency, due to the nature of associated literature, to unwittingly at times use terms that do not belong under the relevant rubric of investigation.

Provinces and related governments are by definition normally objects of study within the domain of national politics but here we see them under interrogation within international relations. The

study of the international activities of these governments is an illustration of the confluence of subdisciplines within political science and speaks to the growing webs of local-global relations and to the dimension of globalization that involves the diminution of the notions of domestic and foreign.

«Atelier sur Internet et la science politique»

[À l'invitation de l'Association belge de science politique (Communauté française de Belgique), notre collègue François-Pierre Gingras a animé une série d'ateliers à l'Université catholique de Louvain sur l'utilisation d'Internet pour l'enseignement et la recherche en science politique. Le Bulletin lui a demandé de résumer son expérience.]

La "commande" de Benoit Rihoux, le secrétaire général de l'Association belge de science politique (ABSP), était claire: il s'agissait "simplement" d'animer un séminaire intensif de deux jours sur l'utilisation des diverses ressources cybernautiques, pour aider les politologues belges, à en tirer le meilleur parti possible tant dans leurs recherches que dans leur enseignement. Mais... il fallait tenir compte que certains collègues d'outre-Atlantique n'en étaient qu'à leurs premiers pas sur l'inforoute, tandis que d'autres possédaient pas mal d'expérience en "navigation" sur Internet.

L'invitation de l'ABSP était inattendue et je l'ai accueillie comme une reconnaissance de l'implication et de l'expertise développée par plusieurs politologues canadiens en matière d'utilisation des nouvelles technologies d'information et de communication (NTIC). Le défi m'a tenté. La préparation des ateliers m'a donné l'occasion de faire le tour de mes expériences personnelles et de faire le point sur l'utilisation d'Internet en pédagogie et en recherche.

Il m'a paru utile et commode de diviser la formation en plusieurs modules:

Une introduction générale à Internet:

- Définitions et illustrations: courrier électronique, environnement W3 (World Wide Web), forums (babillards)

électroniques ou *newsgroups*), protocole de transfert de fichiers (FTP), etc.

- ▶ Insistance sur le fait qu'Internet ne remplace pas la panoplie habituelle des politologues (bibliothèques universitaires, abonnements aux revues savantes, conférences, discussions privées, etc.), mais au contraire ouvre la porte à une nouvelle famille d'outils, qui ont eux aussi leurs limites.

L'utilisation d'Internet en science politique (aspects généraux) :

- ▶ L'intégration d'Internet dans le processus de recherche: de la formulation de la problématique à la diffusion des résultats, un aperçu des possibilités offertes par un usage judicieux du courrier électronique (y compris l'abonnement aux listes de diffusion), de l'environnement W3 et du protocole de transfert de fichiers.
- ▶ Un coup d'œil sur la variété des possibilités offertes par Internet dans le soutien à l'enseignement: préparation de cours, notes de cours électroniques, navigation en salle de classe, communications électroniques avec les étudiants et étudiantes.

L'utilisation d'Internet en science politique (aspects particuliers):

- ▶ Comment déterminer ce qu'on veut savoir.
- ▶ Comment trouver ce qu'on cherche.
- ▶ Comment apprécier ce qu'on trouve.
- ▶ Comment utiliser ce qui est pertinent.
- ▶ Comment améliorer ce qui est disponible.
- ▶ Comment diffuser ses résultats.

L'adaptation aux besoins personnels:

- ▶ Exposé de quelques trucs utiles.
- ▶ Réponses aux questions particulières des participants et participantes.

Les séances se sont déroulées à la mi-octobre, à Louvain-la-Neuve, en présence d'une vingtaine de

membres de l'ABSP, dont son président Jean-Michel De Waele, dans une atmosphère très cordiale et remarquablement détendue. Si j'en crois les commentaires exprimés, de l'avis de tous et toutes, l'expérience fut enrichissante. L'animation des ateliers m'a permis de consolider des liens avec des politologues belges et d'en tisser de nouveaux. Elle m'a aussi fait réaliser que les politologues belges se posent essentiellement les mêmes questions que mes collègues québécois et canadiens face aux NTIC.

Je regrette seulement d'avoir ramené à Ottawa non seulement de délicieuses pralines belges, mais aussi une vilaine infection de la gorge. On peut consulter à l'adresse suivante les notes que j'ai préparées pour l'occasion:

"Do Canadians' Support "Third Party" Election Spending Limits?"

This snapshot of public opinion is based on questions included in the 1997 Canadian Election Study (CES) on behalf of Elections Canada, which made a financial contribution to the project. The 1997 CES was funded largely by the Social Sciences and Humanities Research Council. Field work for this project was conducted by the Institute for Social Research at York University. The sample size for the mailout portion of the study, from which these results are drawn, was 1,857.

The debate in Canada over the regulation of election spending by individuals and groups other than political parties and candidates (so-called third parties) has been ongoing for almost two decades. Just what is the state of public opinion on such questions? Although opinion on these issues may not be very firm, the results of the 1997 Canadian Election Study suggest that there is overwhelming support for spending limits and greater resistance to a ban on third party advertising.

Overall, 35% of respondents were of the view that "only political parties and candidates should be allowed to advertise during election campaigns", while 50% indicated that "advertising by other individuals and groups should also be allowed during election campaigns". The remaining 15% were not sure. The results by region suggest that residents of Quebec are the least supportive of allowing third parties to participate in election campaigns (see table).

On the question of limiting election expenses, only 4% of those surveyed think political parties and candidates should be allowed to spend as much as they want in an election campaign, while 94% think that there should be a limit and 2% were not sure. There are no major difference by region.

Finally, survey respondents were asked: "If individuals and groups other than candidates and political parties are going to advertise during election campaigns, should there be a limit on what they can spend?". Overall, 83% answered yes, 11% answered no, and 7% were not sure.

These results are consistent with those of a study conducted for the 1991 Royal Commission on Electoral Reform and Party Financing. That study found that when faced with the choice of having spending limits for all participants, including third parties, or limits for none, 90% of Canadians opted for controls.

«Les Canadiens sont-ils en faveur de limiter les dépenses d'élection des tiers?»

Le présent aperçu de l'opinion publique se fonde sur des questions incluses dans l'Étude sur l'élection canadienne de 1997 à la demande d'Élections Canada, qui a contribué financièrement à ce projet financé en grande partie par le Conseil de recherches en sciences humaines du Canada. C'est l'Institut de recherche sociale de l'Université York qui a mené l'enquête. L'échantillon postal, duquel sont tirés les résultats présentés dans ce texte, est de 1 857 répondants.

Au Canada, le débat sur la réglementation des dépenses d'élection engagées par les individus et les groupes autres que les partis politiques et les candidats (les tiers ou tierces parties) se poursuit depuis près de deux décennies. Qu'en pensent exactement les Canadiens? Leur opinion n'est peut-être pas définitivement arrêtée, mais les résultats de l'Étude sur l'Élection canadienne de 1997 semblent indiquer que si les Canadiens sont plutôt partagés sur la question de l'interdiction pour les tierces parties de faire de la publicité durant les campagnes électorales, ils semblent en revanche très majoritairement convaincus de la nécessité de limiter ces dépenses.

Dans l'ensemble, 35 % des répondants étaient d'avis que «seuls les partis politiques et leurs candidats devraient pouvoir faire de la publicité pendant les campagnes électorales», alors que 50 % indiquaient que «d'autres personnes et groupes devrait aussi pouvoir faire de la publicité pendant les campagnes électorales». Les 15 % qui restent étaient incertains. D'après les résultats par région, il semble que les résidents du Québec sont les moins en faveur de la participation des tierces parties aux campagnes électorales (voir tableau).

Sur la question de limiter les dépenses d'élection, seulement 4 % des répondants pensent que les partis

politiques et les candidats devraient pouvoir dépenser autant qu'ils le veulent dans une campagne électorale, alors que 94 % pensent qu'il faudrait fixer une limite et 2 % sont incertains. Il n'y a pas de grande différence par région.

Enfin, on a demandé aux répondants : «Si des personnes et des groupes autres que les partis politiques et les candidats pouvaient faire de la publicité, devrait-il y avoir une limite à ce qu'ils peuvent dépenser?». Dans l'ensemble, 83 % ont répondu oui, 11 % non, et 7 % n'étaient pas certains.

Ces résultats concordent avec ceux d'une étude entreprise dans le cadre de la Commission royale sur la réforme électorale et le financement des partis de 1991. Cette étude a permis de constater que devant la possibilité de fixer des limites de dépenses à tous les participants, y compris aux tierces parties, ou de n'en fixer à aucun, 90 % des Canadiens optent pour un contrôle.

The School of Public Administration has developed, in collaboration with the School of Business Management and the School of Social Work at Ryerson, a new Certificate in Interdisciplinary Studies in Nonprofit and Voluntary Sector Management. This Certificate differs from the earlier one offered through the Centre for Philanthropy in that these are university level courses developed through interdisciplinary collaboration. Students will be required to successfully complete 8 out of 11 courses to receive the Certificate. All courses are also being developed in a distance education format (print and electronic). The first two courses [CINP 900 Understanding the Nonprofit/Voluntary Sector and CINP 901 Developing Effective Nonprofit Organizations] are being offered this Fall at Ryerson and via distance education. In the Winter, two more courses will be available [CINP 910 Program Development and Evaluation in Nonprofit Organizations] and [CINP 912 Marketing and Fundraising in the Nonprofit and Voluntary Sector]. The Certificate has generated interest among practitioners across the country, especially in the distance education option. Over 70 students are registered this semester, most are practitioners who almost all have an undergraduate degree. We are interested in working with other universities that in the past offered the Centre for Philanthropy courses which are now being phased out. In particular we have had inquiries about a French version of the courses and would like to work with a partnering university in Quebec.

To highlight the new Certificate, we are sponsoring an Exhibition and Conference entitled: "Spotlight on the Nonprofit Organizations" on November 12 and 13.

Social reporting network

Mike Burke and John Shields of the Department of

Politics and School of Public Administration at Ryerson Polytechnic University are Senior Researchers with the Ryerson Social Reporting Network (RSRN). RSRN was established in May 1996 and is centred around the study of economic and social well-being in Canadian society. Other members of the network are drawn from the fields of sociology and social work at Ryerson and community-based partners.

The idea behind social reporting involves conceptualizing new categories of analysis, collecting new forms of knowledge, constructing new measures, regularly monitoring social and economic trends, and sharing this information in ways that enhance scholarly and popular understanding, social mobilization, and community capacity. The need for social reporting is particularly acute now because all levels of government are withdrawing from responsibility for public welfare while simultaneously claiming that this withdrawal will produce beneficial individual and social outcomes.

Part of the methodological challenge of social reporting, which RSRN has taken up, is to bring fresh conceptual perspectives to existing data sets and use those perspectives to develop alternative indicators of how people are faring under contemporary economic and social conditions. In the 1st Quarterly Report to be released in December 1998 RSRN draws a portrait using new labour market performance indices this involves mapping persistent forms of labour market exclusion, job volatility, measures of the quality of the job stock, employment inequality, and social marginalization that is in marked contrast to the comfortable and complacent views of the state of the labour market we see in governmental budgets and press releases. We use data from Statistic Canada's Labour Force Survey (LFS), a monthly survey of 52,878 Canadian households designed to provide a representative sample of the civilian non-institutionalized population aged 15 years or older living in the ten provinces. The LFS is a rich and regular source of information about the social and economic characteristics of working-age Canadians.

- 3) Centre of Excellence for Research on Immigration and Settlement to study Immigrant/Refugee Youth Unemployment: A Qualitative Exploration of Labour Market Exclusion.

CONGRESS THEME

*World capitalism, governance and community:
toward a corporate millennium?*

As fate would have it, the turning of the millennium has double significance for the International Political Science Association. In 1999 the organisation registers its fiftieth year of service to the discipline, and in the year 2000 itself the triennial world congress will be jointly hosted by the Canadian and Quebec associations in Quebec City. While calendars are at best necessary conventions—and, at worst, extraneous culture-bound constraints—they are nonetheless necessary for celebrations. Fifty years is a respectable age for a modern organisation, and 2000 years (by any calendar) is surely a worthy juncture for taking the measure of an even more ancient field of thought and action.

In choosing the theme "*World capitalism, governance and community: Toward a corporate millennium?*", President Ted Lowi and the executive committee of IPSA have decided to focus on a complex of interrelated issues which are currently having an enormous impact on the boundaries and institutions of global, regional, national and local politics. Though the post-Cold War period is but a decade old, it has been a decade of exceptional change and impact for this century. The decline of aggressive missionary communism throughout the world has left a power vacuum which the new economic constellations of North America, Europe and the Far East are competing to fill; and the ideology of free-market economics has gained world-wide recognition.

The changes in question have increasingly been treated under the rubric of "globalisation", a catch-all phrase which emphasises the emergence of a truly global economy along with the spread of western values and institutions. By shifting the emphasis from "globalisation" to "world capitalism", and by specifically focusing on the *corporate* aspect of change, the main theme of the Quebec congress highlights the organisational and goal-oriented dimension of the process. "corporate" refers, in this sense, not only to the institutional driving force of an increasingly globalised capitalism (multi- and cross-national corporations), but also to what appears to be a more general tendency toward supranational economic and political organisation at the expense of state power and identity. The European Union, NAFTA and the World Trade Organisation, while all ostensibly free-trade organisations, also contain a vital aspect of corporate thinking: the merging of disparate collective actors and interests into a new hierarchically structured and legally regulated body.

By posing the rhetorical question as to whether we are moving toward a new era of both vastly more powerful and essentially different corporate forms and processes, the main theme lays down a challenge for political scientists of all sub-disciplines to bring their findings, perspectives and opinions to the debate in Quebec. What are the effects of "the corporate turn" on existing forms of governance and community? How will the transition from a primarily nation-based system of economic production and competition to an increasingly integrated system of world capitalism and regional corporate-political coordination of trade and markets, affect traditional models of democratic governance and citizen identity? What new power constellations and alliances are emerging, and how can we assess the balance between positive and negative effects? Panels and special sessions related to the main theme will be grouped under five major sub-themes:

- ▶ Globalisation, sovereignty and legitimacy

- Citizenship, values and identity
- Institutions, interests and policies
- World politics, environment and development
- Theory, knowledge and technology.

The members of the programme committee will serve as session convenors for the main theme, actively seeking a limited number of panel chairs to highlight the theme across a broad spectrum of regions and sub-disciplines. The sub-themes can also serve as rough guidelines for those wishing to propose individual papers, panels, special sessions, round-table discussions, or sessions of other types, and IPSA's research committees and study groups will be encouraged to consider the sub-themes when they propose their own sessions of panels. The programme chair will make every effort to coordinate sessions so that it will be possible for those with sub-disciplinary interests to attend as many sessions within a given area as possible.

In conclusion, I would like to stress that a main theme is just that—a *main* theme. When successful, it serves to focus an important issue, inspire debate, and—hopefully—attract participants who might otherwise not attend the congress. The main theme can be viewed in this respect as a large tone-setting symposium within the congress itself. As everyone who has ever attended an IPSA world congress knows, however, the scope and heterogeneity of sessions and activities is enormous; and we hardly expect the millennium congress to be any different in this respect. On the contrary, we believe that the programme for the Quebec 2000 congress will be the largest and most exciting in the organisation's 50-year history. The debate in Canada itself on issues of federalism, sovereignty and identity; the crucial issues relating to the further consolidation of the European Union; the growing importance of global issues of environment and development; issues of democratisation, human rights, and the clash of civilisations—all these and much, much more will complement, supplement and enliven the

programme in Quebec.

Participation on the programme is open to all political scientists who are either individual members of IPSA or members of national associations affiliated with IPSA. Other individuals may also participate, as provided by the guidelines set down by the Programme Committee. Proposals to submit papers or to convene other types of sessions (panels, roundtables, workshops, etc.) may be made directly to the Programme Chair. All proposals should include detailed information on institutional affiliation of the proposed convenor, and proposals for sessions should include a brief description of the nature of the session and a list of anticipated participants.

The deadline for proposing sessions is December 1, 1999, and the deadline for proposing papers is April 1, 2000. No proposals for program listings will be accepted after these dates.

More detailed information on congress procedures and deadlines will appear in IPSA's bulletin, *Participation*, and will be circulated by other means. Proposals for sessions, panels and papers can, however, already be forwarded to the programme chair at the addresses below, or directly through the current programme web site at: <http://afux.prosus.nfr.no>.

Comme par hasard, la fin du millénaire prend une
double signification pour l'Association
internationale de science politique. En 1999,
l'organisation en sera à sa cinquantième année au
service de cette discipline, et en l'an 2000, les
associations du Québec et du Canada accueilleront
conjointement le congrès mondial triennal dans la
ville de Québec. Cinquante ans est un âge
respectable pour toute organisation moderne, et
2000 ans (tous calendriers confondus) représentent
certainement une bonne occasion pour prendre la
mesure d'un champ de pensée et d'action encore
plus ancien.

En choisissant le thème «Capitalisme mondial,
gouvernance et communauté: vers un millénaire des
corporations», le président Theodore Lowi et le
comité exécutif ont décidé de concentrer l'attention
sur un réseau complexe de problèmes qui ont en ce
moment une influence considérable sur les frontières
et les institutions de la politique globale, régionale,
nationale et locale. Bien que la guerre froide ne
remonte qu'à dix ans, cette décennie fut une période
de changements exceptionnels se répercutant sur
tout le siècle. Le déclin du communisme
missionnaire a laissé un vide au niveau du pouvoir
mondial, vide que les nouvelles constellations
économiques de l'Amérique du Nord, d'Europe et
d'Extrême-Orient s'efforcent de remplir.
L'idéologie de l'économie de marché est maintenant
reconnue mondialement.

Ces changements ont de plus en plus été traités sous
la rubrique «globalisation», expression générale qui
souligne l'émergence d'une économie véritablement
globale ainsi que la généralisation des valeurs et des
institutions occidentales. En déplaçant l'accent de la
«globalisation» vers un «capitalisme mondial», et en
soulignant de façon spécifique l'aspect corporatif de
ces changements, le thème principal du congrès de
Québec met en évidence la dimension
organisationnelle qui alimente ce processus.
«Millénaire des corporations», en ce sens, réfère au
moteur institutionnel d'un capitalisme de plus en
plus globalisé (entreprises multi- et
transnationales). Mais aussi à ce qui semble être une
tendance plus générale vers une organisation
politique et économique supranationale qui rivalise
l'identité nationale et le pouvoir de l'État. L'Union
Européenne, l'ALÉNA et l'Organisation Mondiale
du Commerce, tout en étant des organisations de
libre échange contiennent également un aspect vital
de réflexion collective: la fusion d'acteurs et
d'intérêts collectifs disparates en une institution
nouvelle structurée selon une hiérarchie et réglée
légalement.

En posant la question rhétorique de savoir si nous
allons vers une ère internationale de formes
corporatives à la fois beaucoup plus puissantes et
essentiellement différentes, le thème principal lance

un défi aux politologues de tous les champs disciplinaires afin qu'ils contribuent au débat de Québec à travers leurs perspectives différentes. Quels sont les effets du «tournant corporatif» sur les formes existantes de gouvernement et de communauté? Comment la transition d'un système de concurrence économique essentiellement étatique vers un système de plus en plus intégré de capitalisme mondial affectera-t-elle les modèles traditionnels d'identité et de gouvernement démocratique. Quelles sont les constellations et les alliances de pouvoir qui émergeront? Comment pouvons-nous maintenir l'équilibre entre les effets positifs et négatifs?

Un effort sera fait de regrouper les séances du thème principal ainsi que des comités de recherches et des sessions spéciales selon cinq sous-thèmes majeurs:

- ▶ Globalisation, souveraineté et légitimité
- ▶ Citoyenneté, valeurs et identités
- ▶ Institutions, intérêts et politiques
- ▶ Politique mondiale, environnement et développement
- ▶ Théorie, connaissances et technologie

Les membres du comité du programme agiront en tant que coordonnateurs des sessions regroupées sous ces rubriques, et s'efforceront de trouver un nombre limité d'organiseurs de sessions selon une gamme variée de régions et de champs sous-disciplinaires. Les sous-thèmes peuvent également servir de guides pour ceux qui souhaitent proposer des communications, des sessions spéciales, des tables rondes, ou des sessions d'autres genres. Les comités de recherche et les groupes d'études de l'AISP sont encouragés à considérer ces sous-thèmes quand ils proposeront leurs propres sessions. Le directeur du programme s'efforcera de coordonner les sessions de telle sorte qu'il soit possible pour ceux qui s'intéressent particulièrement à un domaine sous-disciplinaire de participer au maximum de sessions dans ce

domaine.

En guise de conclusion, j'aimerais insister sur le fait qu'un thème principal n'est que ça — un thème principal. Toujours est-il, que le thème principal ne représente qu'un tiers du programme complet du congrès. Il y a aussi les sessions spéciales que tout membre de l'AISP peut proposer et les sessions organisées par les comités de recherche et les groupes d'étude qui viennent compléter le programme dans sa totalité. Néanmoins, utilisé à bon escient, le thème principal sert à concentrer l'attention sur un problème important, à inspirer des débats, et — espérons-le — à attirer des participants qui n'auraient peut-être pas pris part au congrès autrement. Le thème principal peut être envisagé comme un grand symposium donnant le ton au congrès. Comme les adeptes des congrès mondiaux le savent bien, la gamme et l'hétérogénéité des sessions sont toujours considérables. Nous ne nous attendons pas à ce que le congrès du second millénaire diffère dans ce domaine. Au contraire, nous espérons que le programme pour le congrès de l'an 2000 à Québec sera le plus important et le plus stimulant des cinquante ans d'histoire de l'organisation. Le débat au Canada sur les problèmes de fédéralisme, de souveraineté et d'identité; les problèmes cruciaux tenant à la consolidation de l'Union Européenne; l'importance grandissante des problèmes d'environnement et de développement; les problèmes de démocratisation, de droits de l'homme et de choc des civilisations — tout ceci et bien plus encore viendra enrichir le programme au Québec.

Des informations plus détaillées sur les procédures et les dates limites du congrès paraîtront dans un prochain numéro de Participation.
