# **Brock University**

## The Department Scene:

Hevina Dashwood was granted tenure and promoted to the rank of Associate Professor. Matthew Hennigar accepted a second one-year appointment for 2004-2005. David Whorley resigned his position in the Department in order to accept a post with the Government of Canada. Jackie Dix retired from her position of many years as Departmental Seminar Coordinator. She and David will be missed.

A team of external reviewers, consisting of Thomas Hueglin (Political Science, Wilfrid Laurier University), Andrew Sancton (Political Science, University of Western Ontario), and Lewis Soroka (Economics, Brock University), was invited to conduct an academic review of the Department. Their report provides useful advice to both the Department and the University administration on several matters.

### **Members' Activities:**

Leah Bradshaw will be participating in a political theory workshop on "Citizenship and Technology" at the CPSA meetings in Winnipeg in June. She will be on sabbatical leave from January to June, 2005, and will be working on a book on tyranny.

Charles Burton spoke to the Canadian Institute of International Affairs on "China's New Global Role and the Rumours of War" at the National Arts Centre, Ottawa, in April. He also participated in a policy seminar with the Dalai Lama in Ottawa during April. He gave a series of lectures in Chinese (10 hours worth) on "Comparing the Chinese and Canadian Political Cultures" at Wuhan University in May, and also spoke at Hebei Normal University and People's University in Beijing thereafter. He will be on sabbatical leave from July to December, 2004, and will be working on a book manuscript, *North Korea and the New World Order.* His most recent publication is Charles Burton, Kristiana Powell, Thomas Kwasi Tieku, with Edward Ansah Akuffo, "The African Union's Standby Force: Canadian Foreign and Defence Policy Options," *Canadian Foreign Policy* vol. 11, no. 1 (Fall 2004), pp. 47-80.

Terry Carroll is presenting a paper, co-authored with Barbara Wake Carroll (McMaster), titled "Civil Society, Democracy, and Development" at the CPSA meetings in Winnipeg in June. He will be on sabbatical leave from July 2004 to June 2005, carrying out research on "Democracy, Development and Inequality in Ethnically Divided Societies". This project involves spending several months doing interviews in each of Botswana, Ghana and Mauritius. His most recent publication, co-authored with Barbara Wake Carroll (McMaster), is "The Rapid Emergence of Civil Society in Botswana", *Commonwealth and Comparative Politics* 42:3 (forthcoming November 2004).

Hevina Dashwood presented a paper at the International Studies Association (ISA) conference in Montreal in March on "Norms Dissemination and Corporate Social Responsibility: An Assessment of Global Processes and the Global Mining Initiative".

Matthew Hennigar was awarded an Internal SSHRC Seed Grant for a project examining the Canadian federal government's attempts to influence, through legal argument, the Supreme Court of Canada's interpretation of the Charter of Rights and Freedoms. His most recent publication is "Expanding the 'Dialogue' Debate: Canadian Federal Government Responses to Lower Court Charter Decisions", Canadian Journal of Political Science 37:1 (March 2004), 3-23. He also presented a paper titled "The

Politics of Avoidance: The Canadian Government's Litigation Strategy in Sexual Orientation Cases" at the Southern Political Science Association meetings in New Orleans in January.

Ken Kernaghan is to receive the award for teaching excellence for the Faculty of Social Sciences, Brock University, for 2003-2004. He was Chair of the federal government Task Force on the Disclosure of Wrongdoing, which reported to the minister at the end of January. Legislation based on their report was introduced in Parliament (Bill C-25), and referred to committee.

Dan Madar will be on sabbatical leave from January to June, 2005.

Garth Stevenson presented a paper at the Midwest Political Science Association in Chicago on April 15, 2004 entitled "The Rise of Separatist Nationalism in Liberal Democratic States: Two Case Studies." His book, *Unfulfilled Union: Canadian Federalism and National Unity*, has just been republished in a fourth edition with a new introduction, this time by McGill-Queen's University Press.

Livianna Tossutti's recent publications include "Does Voluntarism Encourage Young Newcomers to Participate in Politics?: assessing the potential of individual and group-based forms of unpaid service", *Canadian Ethnic Studies/études ethniques au Canada* (2003) 35 (3): 1-15; and "A Tradition of Social Capital in Minority Communities', *Canadian Diversity/Diversité Canadienne* (Spring 2003) 2 (1): 17-9. # **University College of Cape Breton**

## **The Department Scene:**

Andrew Molloy concludes his two-year term as chair. David Johnson will be the new chair for a two-year term beginning 1 July 2004. Brian Howe has recently been promoted to the rank of full professor. The department is in the process of hiring a new 12-month position in International Relations and an 8-month sabbatical replacement position. The 12-month position may be turned into a probationary, tenure track position in 2005.

### Department member activities:

Dr. Lee-Anne Broadhead's teaching and research have continued to focus on international relations with a primary emphasis on political economy/globalization and the environment. A recent paper brought these themes together: "The Gender Dimension to the Search for Global Justice" *Canadian Woman Studies/les cahiers de la femme* Vol 21/22: 4/1 (2002). In addition to this work, Lee-Anne has begun working on the social and political implications of nanotechnology (along with Dr. Sean Howard, adjunct professor in the department) specifically in the areas of environment and militarism. Lee-Anne and Sean presented a paper at the 53rd Pugwash Conference on Science and World Affairs in the summer of 2003 entitled: "Pausing on the Brink: Assessing the Security and Environmental Dangers of Nanotechnology." Subsequent to that presentation, they published a short piece, "The Heart of Darkness" in *Resurgence* Number 221 (Nov/Dec 2003). Lee-Anne is also a collaborator in a Canadian Institute for Health Research and Institute for Aboriginal Peoples Health (CIHR/IAPH) research project, Integrative Health and Healing, that brings together health and university researchers and Mi'kmaq communities in Atlantic Canada. She was appointed Director of UCCB's Centre for International Studies in July 2003.

Jim Guy will be going on sabbatical to complete work on the 6th edition of *People Politics and Government* for PearsonEducation. This popular introductory text, now in its 20th year of production, is used in 28 Canadian universities and 3 U.S. universities. Jim has completed two contributions on Political Science and Taxation for the *Encyclopedia of Politics: Left and Right*, which is published by Golson Books in New York. The text is scheduled for publication in 2005. An updated contribution to Canada, The New Millennium Series, on "Parliamentary Government in Canada" is to be published this year. Jim is considering doing a single authored text on Canadian government with PearsonEducation.

Brian Howe has had a new book (co-authored with Professor Katherine Covell) *Empowering Children: Children's Rights Education as a Pathway to Citizenship* approved for publication by the University of Toronto Press. It is due for release in January 2005. He also has published the articles "Child Poverty in Canada and the Rights of the Child", *Human Rights Quarterly* 25 (Fall 2003), 1067-1087, and "Prenatal Care and the Rights of the Child", *Children's Legal Rights Journal* 22:3 (Fall 2002), 2-13, and book reviews of David Herring, *The Public Family* in *Perspectives on Political Science* 33:2 (Spring 2004), 120, and William Boyce, *A Seat at the Table: Persons with Disabilities and Policy Making* in *Canadian Public Policy* 28:3 (Fall 2002), 487-488. He also presented the paper "Children's Rights Education as Citizenship Education," at the Fourth Annual International Conference of the Citizenship Education Research Network, Dalhousie University, June 2002, and received a research grant from Canadian Heritage for children's rights education, Spring 2003, and a SSHRC-CURA Award: Phase I (with Professor Katherine Covell) for a study of the implementation of the new Youth Criminal Justice Act, Spring 2003.

David Johnson and Andrew Molloy have recently been awarded a 3-year, \$71,000 SSHRC Standard Research Grant to critically assess issues surrounding federal public service renewal. The full title of the project is: "The Federal Public Service Confronts Inter-Generational Change: New Professionals, New Public Management, and New Leadership in an Evolving Bureaucracy".

David Johnson has a forthcoming article for the IPAC Executive Styles' Project. "The Power of One: Premierial Leadership in Nova Scotia", in Michael Howlett, Chris Dunn, Keith Brownsey, eds., *Executive Styles in Canada: Cabinet Decision-Making Structures and Practices at the Federal and Provincial Levels* (Toronto: University of Toronto Press, forthcoming). David is co-editor, with Susan Hodgett and Steve Royal, both of Queen's University, Belfast, of *Doing Development Differently*, to be published by Fernwood Press. David was recently retained by the federal Privy Council Office and the Department of Justice to serve as an expert witness in litigation respecting the constitutionality of federal electoral boundaries in New Brunswick (*Carmel Raiche et al.* v. *The Queen*).

Andrew Molloy is Director for the Centre for Research on Employment and Work (CREW) at UCCB. Andrew is currently organizing a conference for the spring of 2005. He published a book review of Greg McElligott, *Beyond Service: State Workers, Public Policy and the Prospects for Democratic Administration* for *Labour/Le Travail*. A paper was presented on "Viewing Voters and Building Boundaries: A Critical Analysis of Electoral Distribution Law and Practice in Canada," (with David Johnson) at the Squaring the Circle: The Courts in Democratic Canada Conference, Mount Allison University in March of 2003. A paper on "Local Coal Industries in a Global Market: Change and Transition in the Cape Breton and Queensland Coal Fields" was presented to the North Atlantic Forum (NAF) Conference, University College of Cape Breton in June of 2003.

# **Carleton University**

The Department of Political Science at Carleton University has continued to strengthen its reputation not only as one of the leading political science departments in Canada but also as an internationally recognized unit. We have made ten full or cross-listed tenure-track appointments in the last five years

across all areas of political science, allowing us to continue adding to our key teaching and research strengths.

# **Appointments and Promotions:**

We were pleased to welcome no less than six new colleagues in 2003-4. In global political economy, Randall Germain joined us from the Department of International Politics at the University of Wales, Aberystwyth. The author of *The International Organization of Credit* (Cambridge, 1997), he is currently finishing a British ESRC-funded project on global financial governance.

Brian Schmidt joined us from SUNY-Albany. He has also previously taught at Aberystwyth, and is the author of *The Political Discourse of Anarchy: A Disciplinary History of International Relations* (SUNY Press: 1998). Brian brings outstanding strengths in IR theory to the department and will further establish us as a leading centre of international relations research both in Canada and internationally.

In public policy, Vandna Bhatia joined us from McMaster, where she is completing her Ph.D with William Coleman. Her work on health policy reform has already appeared in the *Canadian Journal of Political Science* and we are very pleased to have her as part of our longstanding strength in public policy.

Jeff Sahadeo is cross-appointed with the Department of Political Science and Carleton's Centre for European and Russian Studies (EURUS). Jeff was previously at the University of Tennessee-Knoxville but is very glad to return home to Canada. His expertise in Russia and Central Asia reaffirms Carleton's commitment to area studies.

Additionally, Mark Wolfgram (Ph D, Wisconsin-Madison) accepted a two year term appointment with us in European politics. Mark's work on German political identity has appeared in several journals and books and he is teaching courses in European and comparative/industrial politics. Finally, Keith Child (Ph D, Queen's) joined us for a one-year appointment, teaching courses in African and comparative/developing politics, which is also his area of research.

We are also pleased to announce that Jonathan Malloy and Edward Osei-Kwadwo Prempeh have both been granted tenure after completing their probationary appointments.

### **Teaching and Research News:**

Mira Sucharov received a \$15 000 Teaching Achievement Award from Carleton for excellence in her field. Mira has become one of our outstanding teachers since joining the department in 2001, and she plans to use her award to develop and improve ways of teaching in the controversial area of Middle East politics. As well, William Walters was invited to be a Visiting Fellow in the Department of History and Civilization at the European University Institute in Florence for the spring term.

The Department did well in the 2003-4 SSHRC competition, winning three new grants all in the broad field of Canadian politics. Both Radha Jhappan and Jonathan Malloy received individual grants, for research on child pornography policy and "Canadian Evangelical Christians, Political Institutions and Political Opportunities" respectively.

As well, François Rocher was awarded a SSHRC grant as principal investigator for "Transformations des politiques publiques d'immigration, d'intégration et de citoyenneté et de la demande sociale des minorités racisées au Québec et au Canada" along with Micheline Labelle (UQAM) and Rachad Antonius (UQAM). This is the latest of three related research grants Francois has received. He is also a co-investigator for "Nationalisme majoritaire et diversité culturelle" with a team led by Alain-G. Gagnon (McGill) and a co-investigator for "Observatoire international sur le racisme et les discriminations" with a team led by Micheline Labelle (UQAM). Congratulations, Francois!

# **Concordia University**

During the academic year 2003-2004, we hired four tenure-track faculty, bringing our total tenured/tenure-track faculty complement to twenty-six. We also hired four limited-term faculty and we are in the process of filling a Junior Canada Research Chair in Comparative Public Policy. Our intent is to hire another two tenure-track faculty during 2004-2005 in the areas of political theory and Canadian politics. Sixteen hires have joined the department in the last six years - making them the majority of the tenured/tenure-track faculty.

We have indeed made a tremendous leap in the rebuilding our full time faculty complement but rapid increases in student enrollment leave us still playing catch-up. Had it not been for our increasing undergraduate enrollment of both programme (majors and Honours) students as well as FTEs and had we instead maintained our enrollment at the 1998 level, we would already have reached our goal of renewal of our full time faculty in 2002-2003. The challenge for us has been continually to revisit our faculty complement target in light of the consistent increases in the number of our programme students and in our undergraduate enrollment. The number of programme students has increased almost 60% in six years, from 992 in 1996-97 to 1,560 in 2003-04.

A major accomplishment this year has been to complete our proposal for a Ph.D programme and to have ushered it through approval by several university bodies. We plan to submit this proposal to the Ministry of Education in June 2004.

# New Appointments in 2003-2004:

- Graham Dodds:Assistant Professor
  Graham G. Dodds is completing his Ph.D. from the University of Pennsylvania while working as a
  Research Fellow in the Governance Studies Program at the Brookings Institution in Washington,
  DC. Graham's main scholarly interests are in U.S. politics, public law, and political theory. His
  dissertation examines the presidential use of executive orders and their place in American
  political and constitutional development. Graham has published on the relationship between
  presidents and the press, political apologies, and game theory and Hobbes. He has taught a
  variety of courses at the University of Pennsylvania and also has significant work experience in
  U.S. government and politics.
- Ed King: Assistant Professor
  Ed King expects his Ph.D. from the University of California at Berkeley in June 2004. He is currently engaged with completing his book on the political rhetoric and pedagogical interests of Niccolo Machiavelli, entitled *Rolling a Stone for the Medici: Machiavelli as Political Pedagog.* His interests include European Medieval and Renaissance political theory, the Scottish Enlightenment and more generally how rhetoric in all its forms affects the political imagination. He is working on the effect of film and television on the political assumptions of North American citizens, fanaticism as a historical phenomenon, the political future of an unconscious civilization and the etymology of narrative assumptions of North American political self-identification. His articles include the rhetoric of Adam Smith: "Adam Smith and the Logic of the Schools" *The Journal of Scottish Philosophy*, current edition Spring 2004 and an examination of the political allegories of Dante: "Saving Virgil" in *Dante and the Unorthodox*, University of Toronto Press

forthcoming May 2004. He is working on a book proposal that examines the medieval basis for much of American political culture tentatively entitled *The Black Knights of the White House or The Virgin in the Rose Garden: the Medieval Roots of American Political Culture.* Ed King is a member of the American Political Science Association and has applied to the Canadian Political Science Association

- Leander Schneider: Assistant Professor
  Leander Schneider received his Ph.D from Columbia University. During 2003-2004, he was a
  postdoctoral fellow in the Program in Agrarian Studies at Yale University. Schneider's research
  focuses on comparative politics with a specialization in development and Africa. His dissertation
  which dealt with the issues of democracy and development in Tanzania critically evaluates the
  meta-narratives of development and suggests an alternative framework to examine the role of the
  state, international agencies, the political imaginings, discourses and practices that shape the
  development field. Schneider is currently completing a book manuscript entitled
  Developmentality: State Paternalism in Postcolonial Tanzania. On the level of theoretical
  concerns, the project grapples with the theme of political authority and the question of what
  shapes political action. Schneider has published in journals such as The Canadian Journal of
  African Studies, History in Africa, International Interactions: Empirical and Theoretical Research
  in International Relations.

  Travis D. Smith expects his Ph.D. from the Department of Government at Harvard University in
  2004. His principal research interests include early modern political philosophy, bioethics, and
  religion and politics. His dissertation inquires into the role of medicine in early modern thought
  and its moral and political implications through a close examination of the works of Francis
  Bacon, René Descartes and Thomas Hobbes. Prof. Smith has been a teaching fellow in the
  Committee on Degrees in Social Studies at Harvard for two years. He is a member of the
  Canadian Political Science Association, the American Political Science Association, the American
  Philosophical Association, Civitas, and the New York State Political Science Association.

# Mobilité internationale étudiante / International Student Exchanges

Le nombre d'étudiants et étudiantes de l'École intéressés à profiter des programmes d'échanges internationaux a augmenté de 400% depuis deux ans. En collaboration étroite avec le Bureau international de l'Université d'Ottawa, l'équipe de direction de l'École est en train de développer des liens avec un nombre croissant d'établissements étrangers. ## St. Thomas University

He has two degrees from the University of Calgary and a PhD in Political Science from the University of Alberta (2000). His teaching and research interests are in Canadian politics and government, constitutional law and politics, federalism, and the Canadian Charter of Rights and Freedoms. He is also interested in the relationship between liberalism and religion. Before coming to STU, Professor Bateman taught political studies at Augustana University College in Camrose, Alberta.He is co-editor (with Roger Epp) of *Braving the New World: Readings in Contemporary Politics*. 3rd edition. (Nelson, 2004) and has published articles in the *Canadian Journal of Political Science*, the *International Journal of Human Rights*, *Policy Options*, and other popular outlets. In 2003, he spent five months in the Republic of Slovakia

studying the problem of corruption in the post-Communist central European countries. At STU, Professor Bateman teaches courses on Canadian politics and government, federalism, the Charter, and this autumn will co-teach a course in STU's Great Ideas program on "Technology and Human Nature."

Mikhail Molchanov joined STU in 2003. He received a MSc in Public Administration from New York (1993), PhD in Philosophy from Ukraine (1989), and PhD in Political Science from Alberta (1998). His areas of teaching are comparative and international politics. Dr. Molchanov conducts research in comparative nationalism, domestic sources of foreign policy, and political economy of transitions in Russia, Ukraine, and other post-Soviet states.

Over the last ten years, Professor Molchanov taught classes and guest lectured in Ukraine, Canada, Japan, and the USA. He has published three books in Ukraine and two books in the USA, including, most recently, *Political Culture and National Identity in Russian-Ukrainian Relations* (2002) and *Ukrainian Foreign and Security Policy* (2002, co-editor and co-author). His articles appeared in *The Harriman Review*, *Nationalities Papers*, *Canadian Slavonic Papers*, *The Ukrainian Review*, and *Polis* (Moscow).

At STU, Professor Molchanov teaches Comparative Politics (POLS 3306), Law, Power, and Global Politics (POLS 1603), and Honours Thesis Proposal (POLS 3913), as well as upper-level seminars in comparative politics. He says that his primary goal, as a professor at an undergraduate liberal arts university, is to expand students' critical thinking skills and knowledge of modern politics and society.

# **University of Saskatchewan**

## Retirements:

**John Courtney** was in his first teaching job at Brandon University when Norman Ward recruited him for Saskatchewan in 1965. He brought with him research interests that centred on the political party and branched out from there to the selection of party leaders and the concept of political leadership itself. He was to introduce here an innovative course on political leadership that proved highly popular with students-this year being no exception, with its enrolment of 40.

He wrote two books on the selection of party leaders, the later of which, *Do Conventions Matter?* Choosing National Party Leaders in Canada (1995) was especially timely, catching the selection process in a state of flux. A growing interest in electoral systems drew him into controversy over the wisdom of adopting proportional representation in Canada (he became the media's go-to academic on the skeptics' side of the issue) and resulted in two books: Commissioned Ridings: Designing Canada's Electoral Districts (2001), which became at once the standard source on the subject (he had his own experience as a commissioner to draw upon), and Elections: The Canadian Democratic Audit. Besides writing books, he has been an editor of five. He was co-editor of the Canadian Journal of Political Science for a three-year term.

By word and deed John Courtney has been an exponent of the view that political science is a useful study, and he has been called upon frequently to testify before parliamentary committees, render expert testimony in the courts, and advise government agencies. He has been campaign manager for a candidate for election in federal politics; moreover, the candidate was elected.

He has contributed to this University's presence internationally by delivering papers at more than a score of conferences held in other countries, and has had visiting appointments at universities in Germany and Israel, and at Harvard and Northwestern in the United States.

All will miss Professor Courtney's office door at 909 Arts which displays a fine collection of cartoons on the theme of dogs eating homework. He will continue to have an active research presence in the department, under the new title of Professor Emeritus.

**David Smith**, came to the University of Saskatchewan in 1964, attracted by the presence of Norman Ward, then the leading scholar in the field of Canadian government. Ward suggested that it might help to make him feel at home in his new surroundings if he did a bit of research on something local, such as the Liberal party in Saskatchewan, which had been neglected by scholars. This suggestion was to give rise to four books-one on the Liberal party in Saskatchewan and one on the party in the West, a third, with Ward as co-author, on the life of a prominent Saskatchewan Liberal politician, and the fourth an edited collection of Saskatchewan documents. His *The Regional Decline of a National Party: Liberals on the Prairies* (1981) received a Canadian Historical Association Certificate of Merit.

As a teacher, David Smith offered a new course on provincial government and a seminar on federalism that could be counted upon to be over-subscribed. He was to be sought out as a thesis supervisor,

guiding 18 students to their M.A. degrees. He was director of graduate studies in the Department for two decades, and served a term as Department Head.

Within the last ten years he completed three books on Canadian political institutions: *The Invisible Crown: The First Principle of Canadian Government* (1995), *The Republican Option in Canada, Past and Present* (1999), and *The Canadian Senate in Bicameral Perspective* (2003). These works skillfully combine constitutional theory with comparative analysis; the second of them won a Smiley Prize for the best book published in the field of Canadian politics in 1998-9.

Among the many other publications to come from his pen (yes, pen) are 150 book reviews. Students visiting Professor Smith's office who had the impression he was in the middle of writing something ... well, they had the right impression. He is a Fellow of the Royal Society of Canada and served for many years as Saskatchewan member of the Historic Sites and Monuments Board of Canada, and has been visiting professor at universities in Japan and Australia. He has received the seldom-awarded degree of D. Litt. from this University for the quality of his work. David will continue, as Professor Emeritus, to pursue his research interests.

**Andrew Hubbertz**, professional affiliate in Political Studies, retired in January 2004. Andrew also served as the Head of Government Publications at the U of S Main Library. His knowledge of governmental records was and legendary, matched only by his unfailing kindness and courtesy. Andy introduced hundreds of students to the arcana of documents. We wish him well in his new home along the Rideau in Manotick, ON.

# **Special Interest:**

Bohdan Kordan will teach POLST 343.3 Post-Soviet Ukraine: Politics of Change and POLST 398.3 Ukraine's Foreign and Security Policy as part of St. Thomas More College's new Summer Study Abroad in Ukraine Program. The program offers U of S courses (Language, Culture, Politics, Religious Studies and History) during July and August in Lviv, Ukraine (a UNESCO World Heritage site) in partnership with the Ukrainian Catholic University.

# **University of Toronto**

This was a year that brought significant change to the U of T Department. First, we welcomed a total of 7 new faculty members. On the main campus, Antoinette Handley (PhD Princeton) adds to our strength in comparative politics, especially African politics. Renan Levine (PhD Duke) brings expertise in American parties, elections, and decision-making.

At UTSC (aka Scarborough), Duncan Ivison (PhD LSE) put an exclamation mark around his arrival by winning the C.B. Macpherson Prize for *Postcolonial Liberalism*.

Meantime at the Mississauga campus, there are four new members of the Department: Anna Maria Bejarano (PhD Columbia) works on Latin American politics. Mark Lippincott (PhD U of T) strengthens the teaching corps in political theory. Wambui Mwangi (PhD Penn) works in postcolonial politics, especially in Africa. And David Pond (PhD U of T) brings insight into Canadian politics after a decade in the Ontario government. David's appointment is especially vital in light of the retirement this year of our colleague Peter Silcox.

The other development, linked in fact to the hiring boom at Mississauga, is that our colleagues at Mississauga have now officially become a Department in their own right. Graham White is the Chair of the new Department; enrolment (and faculty) expansion over the next several years should keep him busy!

(At Scarborough, political scientists are now part of a larger Department of Social Sciences, but with considerable autonomy. Only at U of T!)

Meanwhile, back downtown, Melissa Williams ends her term as Undergraduate Chair. Ran Hirschl, fresh off the publication of his book *Towards Juristocracy* (Harvard, 2004), will take over leadership of the undergraduate program. Don Forbes ends his term as director of the MA programs, to be succeeded by Simone Chambers. And Linda White will assume duties as the coordinator of TAships, succeeding Patricia McCarney who is now the University's Associate Vice-President (International Research and Development).

And finally, some new real estate. The Department is delighted with its new and handsomely appointed seminar room. (If you're in town, check out the room and our Friday afternoon seminar series (http://www.chass.utoronto.ca/polsci/upcoming\_events.htm). And in the same renovation project we've added a suite of new offices to accommodate what we hope will be a mini hiring boom over the next several years. More on that next time.

## **New Appointments:**

Following a number of retirements in rapid sequence during the 1990s, our offerings in Canadian Politics were severely depleted. In a department with an established commitment to the analysis of Canadian issues and in a university with a strong interdisciplinary graduate (M.A. and Ph.D.) program in Canadian Studies, this was a circumstance earnestly in search of a remedy. Accordingly our Dean supported two new appointments, one in 2002-03, and another in 2003-04. The first, Nadine Changfoot, deferred her arrival by one year, electing to complete her SSHRC Postdoctoral Research Fellowship at the University of California, Berkeley, before commencing her teaching responsibilities at Trent. The second, Miriam Smith, has transferred to us from Carleton University. We are delighted to welcome them to our community.

Nadine Changfoot completed her B.A. in Public Policy and Administration at York, her M.A. in Public Administration at Carleton and her Ph.D in Political Science at York. Professor Changfoot is a versatile scholar and teacher whose research covers Canadian politics, women and politics, law and politics and political theory and crosses disciplines with Law and Society, Women's Studies and Philosophy. Her current interests centre on gender and political theory, recognition and reconciliation. Her appreciation for the Canadian polity has been nurtured by her extensive travels throughout Canada, her participation in the women's movement, the labour movement, and her experience as a policy analyst and research analyst with the federal and Ontario provincial governments. Professor Changfoot also worked for three years in the private sector as a management consultant with an Ottawa firm. Nadine's most recent article, "Feminist Standpoint Theory, Hegel, and the Dialectical Self: Shifting Foundations," will soon appear in *Philosophy and Social Criticism*.

Miriam Smith attended McGill University (B.A.) and Yale University (Ph.D). From 1989-2004 she was a member of the Department of Political Science and the Institute of Political Economy at Carleton University. In 2002-03 she was Canadian Studies Visiting Professor at the University of Toronto. She is also affiliated with the Sexual Diversity Studies Program at University College, University of Toronto. Her areas of interest are Canadian and comparative politics, in particular political economy, social movements and the lesbian, gay, bisexual and transgender movements in Canada. She also has a strong interest in institutionalist approaches to the study of politics, Canadian political institutions and public policy. Professor Smith is the author of *Lesbian and Gay Rights in Canada: Social Movements and Equality-Seeking, 1971-1995* (UTP, 1999) and, with François Rocher, co-editor of *New Trends in Canadian Federalism* (Broadview Press, 2nd ed., 2003.) This year she published "Segmented Networks: Linguistic Practices in Canadian Lesbian and Gay Rights Organizing," *Ethnicities* 4:1 (March, 2004). Forthcoming is "Resisting and Reinforcing Neoliberalism: Lesbian and Gay Organizing at the Federal and Local Levels in Canada" in *Policy and Politics*. Profesor Smith's current projects include (1) a study of social movements and neoliberal restructuring in Canada and (2) a study of spatial scales in lesbian and gay organizing, based on a large-scale research project on the lesbian and gay voluntary sector in Toronto.

### The Department Scene:

Our department sponsored or co-sponsored the visits of a number of outstanding speakers. John Ralston Saul's lecture on "The End of Globalization and the Return of the Nation State" packed the Wenjack Theatre and later turned up as a controversial essay in *Harper's* (March, 2004). Daniel Salée came over from Glendon College at York University and favoured us with two excellent talks based on his current research: "Facing the Limits of Political Democracy: Québec and the Political Challenges of Indigenous Peoples," and "Political Change and Social Transformation in Québec: A Status Report." Luis H. Alvarez, Commissioner for Peace in the State of Chiapas, Mexico, spoke about his role in negotiations between the government of Vicente Fox Quesada and the Zapatistas. Jointly with Champlain College, the Department of Political Studies brought the renowned commentator, journalist and historian, Gwynne Dyer to speak about current issues of terrorism, global division and the fallout from British and American involvement in Iraq. Kari Polanyi-Levitt joined the department and the International Development Studies Program to discuss development issues in the Caribbean. Political Studies also supported and helped to

fund the Gilles Deleuze Conference organized by the Department of Philosophy in May. Scholars from around the world participated in this hugely successful four day event.

At the conclusion of the academic year the Department of Political Studies held a "Research Day" during which faculty members read papers based upon current research to colleagues and students. So many students turned out for the event - on a Friday! - that we had to relocate to a larger room. Professors Mark Neufeld and Christie Gombay moderated the panels which included presentations by Stacey Mayhall, Colleen O'Manique, Julian Ammirante, Derek Hall, Feyzi Baban, Davina Bhandar, Jim Driscoll and Miriam Smith. Following the final question and answer period the entire group retired to the Champlain Senior Common Room for a reception. The success of this event has suggested to us that we should try another next year, this time with the addition of a session devoted to graduate and undergraduate student papers.

## **Members' Activities:**

Professors Andreas Pickel and Eric Helleiner have co-edited *Economic Nationalism in a Globalizing World*, forthcoming in 2004 with Cornell University Press. This collection asks whether economic nationalism is an outdated phenomenon in the light of globalization. The volume's contributors, pioneers in the reinterpretation of economic nationalism, explore diverse ways in which national identities and nationalism continue to shape contemporary economic policies and processes. Authors examine the question in a range of geographical contexts and issues: European Union food politics, competitiveness strategies in New Zealand, East Asian development strategies, Japanese liberalization, monetary politics in Quebec and Germany, and post-Soviet economic reforms. Professor Pickel is Guest Editor of two special issues on "Systems and Mechanisms" forthcoming in *Philosophy of the Social Sciences* in June and September of 2004. Also forthcoming (Chicago: Open Court) in 2004 is a translation from the German of Karl R. Popper's *The Two Fundamental Problems of the Theory of Knowledge*. Professor Pickel was promoted this year to the rank of Full Professor.

Derek Hall has two new articles in the works, forthcoming in 2004: "Explaining the Diversity of Southeast Asian Shrimp Aquaculture," *Journal of Agrarian Change* 4:3; "Japanese Sprit, Western Economics: The Continuing Salience of Economic Nationalism in Japan," *New Political Economy* 9:1.

Mark Neufeld has published two new articles in the 2003-04 academic year: "La economía políitica de la seguridad: el discurso sobre la seguridad en la políitica exterior canadiense posterior a la Guerra fría," in Remedia Gomex Arnau et al, eds. Las polítas exteriors de Ustades Unidos, Canadá y Mexico en el umbral del siglo XXI. (Mexico City: UNAM/CISAN, 2003); "Pitfalls of Emancipation and Discourses of Security: Reflections on Canada's 'Security with a Human Face," International Relations 18:1 (March, 2004). In October he received a travel grant to participate in a conference on Gramsci and International/Political Theory at the University of Nottingham. His paper was titled "From Three 'Ds' to Four 'Ps': Reflections on Neo-Gramscian IPE in Light of Luxemburg and Said." Professor Neufeld was also awarded an external SSHRC research grant of \$53,000, over three years, for his project, "The 'Anti-Globalization' Movement: From Dissent to Counter-Hegemony." Beginning in July 2004, Professor Neufeld will assume the Directorship of the Trent International Political Economy Centre.

In addition to becoming the proud papa of Jamie Emre, Professor Feyzi Baban published "Community, Citizenship and Identity in Turkey," in Fuat Keyman, ed. *Citizenship and Identity in a Globalizing World* (London: Routledge, 2004). Forthcoming in fall 2004 in the journal, *Constellations*, is "Cosmopolitanism, Modernity and Political Community". Professor Baban presented a variation of the latter paper at the International Studies Association Annual meeting in Montreal, March, 2004. In the summer of 2003 Professor Baban organized a workshop in Istanbul, Turkey on the subject, "Multiple Modernities: Local Interpretations of Modernity in Distant Locales." The second leg of this workshop will take place at Trent University in fall, 2004. This project is precursor to a book to be edited by Feyzi Baban and Mark Neufeld. In the second term, Professor Baban was an invited guest lecturer at Koc University, Istanbul, Turkey. Here he spoke on "Divided Loyalties and Hybrid Identities: The Turkish Community in Berlin." On this trip he also spoke at the Centre for Turkish Studies in Berlin, Germany on the subject, "Uneasy Road to Membership: Turkey and the European Union." Professor Baban was awarded two internal SSHRC

grants in 2003-04, the first (for \$5000) to support "Deterritorializing the Nation: Transnational Identities and the Turkish Community in Germany," and the second (for \$2000) to support "Local Responses to Modernity: Construction of National Identity in Turkey."

Our excellent part-time colleagues were also amazingly busy on top of very heavy teaching loads. Stacey Mayhall presented her paper, "Relocating the Security 'Battlefield': The 'High' Politics of Global Finance in the Pre-and Early Post- 9/11 Period" at the International Studies Association Annual Meeting in Montreal in March. Tammy Findlay presented three conference papers this year: "Movements Against Neoliberalism," at Leftwords, New College, University of Toronto in November; "State Feminism in an Anti-State Era: Gender, Democracy and Neoliberalism in Ontario," at the CPSA, University of Manitoba, in June; and "Gendered Governance: Neoliberal Restructuring and Democracy in Ontario," at The WTO and Beyond: Global Governance and State Power in the Twenty-First Century, Simon Fraser University, in July. Tammy also published three articles: "Whatever Happened to the Women's Movement?" Canadian Dimension 37:5 (Sept./Oct., 2003); "Resisting 'Tongue-Twister' Language: In Search of a Practical Feminism," in Torry D. Dickinson, ed. Community and the World: Participating in Social Change (New York: Nova Science Publishers, 2003); "Getting our Act Together: Gender, Globalization and the State," Socialism and Democracy 18:1 (January-June, 2004). Julian Ammirante read his paper, "Professional Sport and Spectacle in the age of Globalization" at the CPSA meeting in Winnipeg in June. He is currently at work on "Globalization and Professional Sport: Comparisons and Contrasts Between Hockey and European Football," forthcoming in David Whitson and Richard Gruneau, eds., Artificial Ice: Hockey, Commerce and Canadian Culture.

# The Teaching Program:

With the appointment of our two new colleagues, Miriam Smith and Nadine Changfoot, we are reinforcing the department's commitment to Canadian Politics, strongly anchored by Jim Driscoll, who is cross-appointed with the Canadian Studies Program. Professor Changfoot will direct our second year course on Canadian Politics and our third year course on Women, Law and Politics. Professor Smith will take over our third year course on Canadian Political Economy. She will also offer a new third year course on United States Politics. Of particular interest to Canadianists, however, will be Professor Smith's two new courses, Multilevel Governance in Canada, at the third year level, and Citizen Politics in Canada, at the fourth year level. Both colleagues will bring valuable new expertise to the M.A. and Ph.D programs in Canadian Studies, based in the Frost Centre at Trent. They will also contribute to our graduate program in Theory, Culture and Politics.

Our Theory offerings, which are extremely popular with students, continue to be provided by Professors Jim Driscoll (Canadian Studies/Politics) and Elaine Stavro (Philosophy/Women's Studies). Globalization centres the teaching of Professors Andreas Pickel, Mark Neufeld, Feyzi Baban and Derek Hall (International Development Studies/Politics). The list of colleagues at Trent who are trained as Political Scientists but who find themselves dispersed throughout the University in our many interdisciplinary programs is quite extraordinary: David Morrison, Douglas Torgerson, Davina Bhandar, Elaine Stavro, Eric Helleiner, Robert Paehlke and Colleen O'Manique are formally Associated Faculty with cross-listed courses addressing our three major areas of concentration. Other Associated Faculty who enrich our department from other program and departmental bases include Professors Bryan Palmer, James Struthers (Canadian Studies), Stephen Bocking (Environmental and Resource Studies), Christopher Huxley, James Conley (Sociology), Mark Dockstator, David Newhouse (Native Studies), and Margaret Hobbs (Women's Studies). As a Department of Political Studies we mirror increasingly the evolving interdisciplinary pedagogy and research orientation of Trent University.

## **New Appointments:**

The Department of Political Science at the University of Waterloo is very pleased to welcome Bessma Momani and Sonny Lo to the department.

Bessma Momani will be joining the University of Waterloo's Departments of Political Science and History teaching international organizations and governance as well as Middle East politics and history. Her research interests include the International Monetary Fund, the World Bank, economic integration, Third World development, structural adjustment policies, Middle East politics, and international trade. Dr. Momani's current projects and publications include an examinations of Fund recruitment and surveillance, the IMF and the war on terrorism, promoting US private investment in the Middle East, and the American sponsored Middle East Free Trade Agreement.

Sonny Lo will be joining the Department of Political Science teaching comparative politics including Chinese politics and the politics of Asia. Formerly an Associate Professor in the Department of Politics and Public Administration, Hong Kong University, his books include *Political Development in Macau* (The Chinese University Press 1995), *The Politics of Democratization in Hong Kong* (Macmillan, 1997) and *Governing Hong Kong: Legitimacy, Communication and Political Decay* (Nova, 2001). Dr. Lo is now completing a book about organized crime in Greater China.

# **York University**

### **New Appointments:**

The Department of Political Science appointed three new faculty members in entry-stream, tenure-track positions for the academic year commencing July 1, 2004.

Anna Agathangelou joins us in the field of Women and Politics.
