Ontario Legislature Internship Programme

Report 2004-2005 Henry Jacek, Academic Director

1. Introduction

I have many people to thank for their advice, help and suggestions in my first year as Academic Director of the OLIP. To begin with, a great deal of the work and good advice I received this past year came from Eithne Whaley, our Programme Assistant. Eithne hails from England, and has an honours B.A. in Politics from the University of Essex. Eithne worked in the House of Commons for two different MPs as a research assistant and was also an Intern there.

On our management committee, I was very fortunate to have Ray McLellan from Legislative Research who retired in March of this year after ten years of dedicated service to the Programme. He is succeeded by Lorraine Luski, a former Intern. Tonia Grannum from the Committee's branch of the Clerk's office and her staff have been extraordinarily helpful. My immediate predecessor, Dr. Greg Inwood of Ryerson gave freely of his time in August and September and made my transition into the position easier than I thought it would be. Previous Directors, Bob Williams and Graham White gave me good advice as I took over the job. My McMaster colleague, Catherine Frost, a former intern, gave me good advice continually and once again devoted a good deal of time to the intern selection process.

I did not have a voice in choosing the current Interns (see biographies below) but I must thank the 2004 selection committee for doing an outstanding job. Just about every Friday afternoon, I meet with the Interns to discuss administrative and academic concerns. To sum up my experience with them, I can say that Fridays were the highlight of my week. I will be truly saddened to see them leave at the end of this month.

2. Intern Educational Activities

Although working for two MPPs is the core of the Programme, the educational function is just as important. The September orientation is just the beginning. Meetings with important Parliamentary Officers top the list of important educational activities. Key meetings were with the Lieutenant Governor, the Speaker of the Legislative Assembly, and the Clerk of the Legislative Assembly. Complementing these were meetings with the Auditor General, the Environmental Commissioner, the Ombudsman, the Assistant Chief Election Officer and the Assistant Information and Privacy Commissioner. In addition, there were a whole host of other officials who shared information on the workings of the Legislative Assembly with the Interns and myself. These included many officials from the Committee's Branch, the Legislative Library, the Chief Legislative Counsel, the Sergeant-At-Arms, the Director of Human Resources, the Director of Broadcasting and Recording Services, the Director of Hansard Reporting and Interpretation Services.

Outside of Queen's Park, many of ours sponsors and potential sponsors not only gave a considerable amount of time to the Interns and shared their perspectives on current Ontario policy issues, but also often provided food and other refreshments at lunches and receptions. Well known journalists also made time for the interns. These included Ian Urquhart of the Toronto Star, Graham Richardson and Robert Fisher, both former hosts of Focus Ontario on Global TV, Steve Paiken of TVO, Christina Blizzard from the Toronto Sun and Murray Campbell of the Globe and Mail. The Interns were also impressed with their meetings with former Premiers, Bill Davis and Bob Rae.

In December, the Interns travelled to Quebec City and Ottawa. They were grateful to meet with the former Premier and present Parti Québécois leader, Bernard Landry and other Quebec MNAs. In Ottawa, the Interns had excellent meetings with among other people, NDP MP David Christopherson, a former Ontario cabinet minister, the Clerk and Speaker of the House of Commons and journalist John Ibbitson.

In March, the Interns went to Edmonton and Yellowknife where they met with a variety of government, media and association officers. In Edmonton, the Interns met with a number of legislators and administrative/legislative staff. Important highlights were meetings with the Clerk of the House, the Sergeant-At-Arms, the Leader of the Official Opposition, Kevin Taft and the Minister for Finance and Deputy Premier, Shirley McClellan. The two most memorable meetings were with the Speaker, Ken Kowalski and the Minister of Community Development, Gary Mar. Mr Mar not only gave an important perspective on Alberta public policy goals, but he also treated the Interns to a fine Chinese dinner. Given the meagre per diem of the Interns, the dinner was greatly appreciated. In Yellowknife, Clerk Tim Mercer once again gave freely of his time as did Doug Schauerte, NWT Assembly Table Clerk. The latter

pleased the Interns with a lunch at the NWT's museum. Also the Interns met Glen McLean, Chief Electoral Officer and the Speaker of the Assembly Paul Delorey. Other visits were with Sandy Lee, MLA for Range Lake, Mike Bryant, the editor of the Yellowknifer, the local newspaper, and the Mayor of Yellowknife, Gordon Van Tighem. The trip closed with a midnight view of the dancing green lights of the Legendary Northern Lights.

For the rest of the year, educational activities focused on their paper presentations at these meetings in London, Ontario and the highlight of their educational year, the trip to the mother of Parliaments at Westminster. The educational value of these meetings cannot be overstated. Many of these meetings have led to research papers. I must add that the educational experiences have benefited greatly the Academic Director as well.

3. Fundraising

This has been the most time consuming of my activities. At the time of writing this report, April 14th, we surpassed last year's total. There are a number of reasons for this. At least a couple of cheques arrived after July 1st, invoices were processed earlier this year and the interns were kept busy visiting as a group our past and present sponsors. Not surprisingly, the people we visited were impressed by the bright, hard-working interns and these visits provided an incentive for sponsorship renewal. Some sponsors even dramatically increased their donation as a result. These sponsorships are crucial if the educational component of the Programme is to be maintained.

4. MPP Placements

The interns began their autumn placements in early October and their Spring placements towards the end of February. Fortunately many MPPs wanted an Intern so the Interns had the ability to secure two one term internships with the potential for a major learning experience. As the Interns, present and past would after say, the experience is amazing.
