O.P. Dwivedi, Ph.D., is Professor and Chairman, Department of Political Studies, University of Guelph, Guelph, Canada where he has taught In addition to his academic appointments (including acting Dean of Social Science), he has held visiting appointments with the Brookings Institution, Washington, D.C.; Australian National University, Canberra; and three other Canadian Universities. He has published nine books including Provincial Governments as Employers (co-authored with J.E. Hodgetts, 1974), Protecting the Environment (1974), Resources and the Environment (1980), The Administrative State in Canada (1982), Ethics in the Public Service: Comparative Perspectives (co-edited 1983) abd Ethics in Government: The Public Service of P.N.G. (1984). His study, Public Service Ethics (1978) has been translated into French, Spanish, Arabic and Hindi. In addition, he has written numerous articles in professional journals of Canada, U.S.A., U.K., Belgium, Australia, and India. He has served as policy consultant to the Ministry of State for Urban Affairs, Public Service Commission of Canada, and Environment Canada.

He has been CIDA adviser to the Government of Papua, New Guinea, World Health Organization's consultant to the Government of India, and UNO consultant for the Criminal Justice Section.

Professor Dwivedi has taken active part in the affairs of The Canadian Political Science Association since 1966. He was the first chairman of the Public Administration Section of the CPSA Conference in 1973. He was elected Vice-President of CPSA for 1978-79. And since 1979 he has been chairman of the Study Group on Technology and Development, International Political Science Association. The International Association of Schools and Institutes of Administration (Brussels) appointed him as Director of the Working Group on Public Service Ethics, 2.esponsibility and Accountability in 1975, a position he held until 1983. He has been invited speaker to many conferences and seminars organized in Canada, U.S.A., U.K., Australia, India, Singapore, Fiji, Mexico, Costa Rica and the Ivory Coast.

KEITH BANTING received his B.A. from Queen's University and his D.Phil from Oxford. He has taught at the University of British Columbia since 1973, with the exception of a two-year period at the Institute of Intergovernmental Relations at Queen's. His publications include Poverty, Politics and Policy and The Welfare State and Canadian Federalism. In addition, he was co-editor of And No One Cheered and Redesigning the State.

PETER BOSWELL is Associate Professor and Head of the Department of Political Science at Memorial University of Newfoundland. Born in 1940, he pursued a career in municipal administration prior to attending university. B.A. from University of Toronto, M.A. and Ph.D. from Carleton. Main field of research and publication is local government in Newfoundland; secondary interest in criminal justice policy. Served three years as Secretary-Treasurer of the Atlantic Provinces Political Studies Association and currently a member of the Strategic Planning Committee for the Correctional Service of Canada.

HAROLD CHORNEY is an assistant professor of political science specializing in public policy at Concordia University in Montreal. He has studied economics and political science at the University of Manitoba, where he was named a Woodrow Wilson fellow in 1968, The London School of Economics and the University of Toronto. In addition to articles in several scholarly collections he has published a number of articles and reviews in the <u>Canadian Review of Sociology</u> and Anthropology; <u>Canadian Journal of Political</u> and Social Theory; Studies in Political Economy and the Canadian Journal of Political Science. He has also published in Journals of opinion such as City Magazine, This Magazine and Canadian Dimension. He has written research reports for the Governments of Manitoba and Saskatchewan and the Canadian Centre for Policy Alternatives. He is a frequent commentator on issues in public policy for the C.B.C.

WARREN MAGNUSSON, Assistant Professor of Political Science, University of Victoria, Victoria, B.C. B.A. (Manitoba), B. Phil. D. Phil. (Oxford). Taught formerly at the University of Western Ontario and Ryerson Polytechnical Institute. Specialist in political theory, Irban and local government, and Canadian politics. C.P.S.A. Programme Committee Member, 1983. Co-Editor, City Politics in Canada and The New Reality: The Politics of Restraint in British Columbia. MINUTES

Board of Directors

Universite d'Ottawa

November 24, 25, 1985

The Board met on the last Saturday and Sunday of November. It was an active two days in which beyond its normal business, it welcomed several quests: President Gérard Hébert, Social Science Federation of Canada, Carmen Carroll of the Public Archives of Canada and English Language Secretary of The Canadian Historical Association, Donald C. Rowat (Carleton), former president of the Association and expert on questions of access to information, Profs. Michael Stein (McMaster) and John Trent (Ottawa), and Prof. David Elkins (UBC) .

The Board heard reports from the Directors of its various major programmes: Profs. Herman Bakvis and Grace Skogstad represented The Canadian Journal of Political Science; Prof.
Allan Tupper, "The Bulletin", Prof. André Bernard Two internationally-oriented matters were dealt forwarded his Programme Committee report; Prof. with as follows: Fred Fletcher presented his for OLIP; Prof. Robert J. Jackson, Director, was unable to be present.

The Board made a number of appointments: Prof. Allan Tupper was appointed to a second, threeyear, term at "The Bulletin"; Prof. Fred Fletcher was appointed to his second term as OLIP Director. It was agreed to ask a former president of the Association to act as official scrutineer to the 1985 elections, the need being to provide for this function until the Constitutional Committee could bring a recommendation as to how this might continue to be handled internally for the future MOTION:

Martha Fletcher (Govt. of Ontario), agreed to extend her earlier mandate (to look at the role of non-university-based political scientists), broadening it to consider the whole question of how membership might be increased to counteract the pressures of the new Council funding programme for administration which now looked only at head-count and no longer at programmerichness.

Note was taken of honours that had come to two longstanding members of the Association: Douglas Verney (York) was the 1984 recipient of the Jules Léger Award. Guy Gosselin (Laval) and CPSA/ACSP-SqSp representative to UNESCO was elected to the Executive of that organisation.

President Holsti had written to Dean William Badour of the University of Ottawa (and former Association Vice-President) to thank his university for its helpful support of the Association. The Board recognized the special demands placed on the two Ottawa universities in providing a home for the Association and appreciated the warm helpfulness of their support.

The major items dealt with at these meetings are outlined below in terms of the Motions passed by the Board over the two-day period:

With the Constitutional Committee preparing its work for receipt by the Board in Summer 1985, the following was carried:

MCTION:

That, as a matter of principle, all appointments not specified in the Constitution be for three years, renewable for another three.

That, at the end of the second three-year term, the Executive or a search committee appointed by it for that purpose, undertake a formal review.

That the formal review process would not preclude reappointment but that there would not as a matter of course be reappointment.

That where a reappointment was made to exceed the six-year period it be for a further three-year term, at the end of which the formal review process would again apply.

That the matter of how questions of leave within terms of appointment be interpreted be left to the discretion of the Executive.

MOTION:

That The Canadian Political Science Association agrees to ask La Société québécoise to join it in sponsoring the October 1986 meeting of the Executive Committee of the International Political Science Association at Ottawa, a round table "Beyond Current Political Philosophy/Envers le dépassement de la philosophie actuelle", to be held fol-lowing the meeting itself.

That the Association sponsor the Yugoslav Workshop on the two following conditions:

- 1. that all workshops be organised to protect the Association's concerns for academic openness and freedom.
- 2. that the role of the Secretariat be specifically limited to (1) support of the Executive in its task of appointing the Selection Committee. and (2) the servicing of the Selection Committee by disseminating the call for applications and (3) the subsequent receiving of applications for forwarding to the Selection Committee.

The Association received a letter from Prof. Jacques Lévéille (UCAM) forwarding to it a Motion passed by the departmental committee at his university: "L'Assemblée départementale mandate le directeur du département pour écrire au SPUQ, à la SCSP et à la CPSA pour les mettre au courant de la situation et les presser d'intervenir dans le dossier Mandel."

MOTION:

That a Committee of two Board members be established to study the original CPSA Motion, in the light of the relevant CAUT and Quebec Human Rights Commissions documents and to make to the May Board meeting some recommendations to serve as a basis for discussion.

Profs. Michael Stein (McMaster) and John Trent (Ottawa) brought to the Board on their behalf and that of Prof. André Donneur (UQAM) a State of the Art project, proposing that the Association join the SqSp in publishing it as a special issue of The Canadian Journal of Political Science.

MOTION:

That the Executive Committee structure a Committee comprising one member of the Board, a representative from the ScSp, and chaired by a senior member of the political science community, to study the feasibility, including ways and means if appropriate, of publishing a volume on the state of the art of political science in Canada.

The Board focussed on SSHRCC-related items as part of the watching brief of the Chandler/McRoberts Committee. Prof. David Elkins was welcomed by the Board and, at its request, had prepared a paper on the subject of peer review, for discussion by the meeting.

(The paper is presented in its entirety at the end of this item).*

MOTION:

That President Kal Holsti forward the Elkins document to Council as an expression of Board policy on the question of peer review.

Other issues, among them the track record/project question as related to research grants, were passed on to Profs. Chandler and McRoberts so that they might prepare documentation to quide Board discussion at the meeting of May 30. The Board was most particularly sympathetic to Council's problems in finding assessors and agreed to urge to members the importance of cooperating with Council in this key way.

The one remaining substantive piece of business was that Prof. Holsti agreed to write to the Canadian Historical Association suggesting that rather than mount its own committee in the important area of access to information questions, the Canadian Political Science Association would like to be kept informed of the CHA Committee's progress and, indeed, if the CHA would think that appropriate, would be happy to cooperate in some formal way.

* THE EVALUATION OF APPLICATIONS

We believe that evaluation of applications should continue to involve scholars active in the field. Peer review, however, has several different meanings; and the exact form it should take may be varied according to circumstances. For example, graduate fellowships, Leave Fellowships, and research grants may require somewhat different procedures.

In the case of graduate fellowships, some assessment by faculty who have taught the student and/or by a Department committee seems essential. Grades have different meanings in different universities and fields, and so faculty opinion serves to put them in an interpretable frame of reference.

Leave Fellowships may be a case where less peer review -- in the sense of scholarly assessment letters -- could be acceptable. Colleagues who have served on the selection

committees report that virtually all letters have been strongly positive; thus decisions have apparently been made on the basis of project descriptions, track record, or other (unknown) factors. Of course, selection committees composed of peers are a form of peer review, and thus many applicants might accept a situation in which no letters of evaluation are sought. In that case, however, it might be beneficial to allow a slightly more detailed description of the project. The dilemma, of course, is apparent: The more detailed the project description, the more one needs scholarly appraisal of its merits and potential. If Leave Fellowship applications become indistinguishable in their length and detail from small research grants, the procedures of evaluation will also need to be similar.

Research grants (including Major Grants and Strategic Grants as well) pose the greatest challenge. The problem in recent years has been a decline in the response rate to Council requests for assessments, partly because Council no longer pays assessors (except for Major Grants) and partly because of the greatly increased number of applications. Once received, however, these evaluations are useful and informative. They must not be abandoned under any circumstances. Instead, as an association we feel some obligation to try to encourage our members to accept their responsibility to write such evaluations.

Some have argued that the establishment of Adjudication Boards obviates the need for letters of evaluation from independent scholars. It is true that the adjudicators are peers, and this is therefore one form of peer review. None of the Adjudication Boards relevant to Political Science applications, however, can be large enough to encompass representatives from all fields of the discipline. Their judgements must continue to be based on as much information as possible from scholars who are experts in the same field as the applicant. In many cases, fewer awards can be made than are assessed favourably, leaving a crucial role for adjudicators. This in no way supports an argument that the adjudicators could operate effectively without any assessments. Furthermore, one result of the expert scholarly assessments concerns the adequacy of budget requests: a good assessor can help adjudicators trim budgets so that more applications can be at least partially funded. This allows researchers to request funding in future periods on the basis of some progress, facilitating the work of assessors and of adjudicators.
