#### 1. 1987 Annual Conference

#### 6. The Essex Scholarships

Professors Réjean Landry (Laval) and Patrick James (McGill), and Pierre Martin, a Canadian graduate student at Northwestern University, were the 1987 Essex Scholars and spent a minimum of 4 weeks during July and August attending the University of Essex (Colchester, England) Summer School in Data Collection and Analysis. The Association, with a grant provided by the SSHRCC has, for the last 13 years, sent 3 (or sometimes 4) members to this highly-reputed programme. The quality of the candidatures remains extraordinary. Each year a Boardappointed Selection Committee made up of three experts in the area of the scholarship, has a task of Solomon before it. Members are invited to write to the Secretariat, before year-end, so that they may be provided with information in order to complete, by mid-February, applications for the programme which is open to both senior graduate students and to faculty members.

#### 7. The Directory Project

Some very Good News: We are delighted to announce that Professor David Smith of the University of Saskatchewan has agreed to take on the task of carrying forward the DIRECTORY project!

You will remember that the project became stalled after the 1985 draft. The Association has long had a strong sense (and at many levels: Journal Programme Committee membership concerns, etc., etc.) of the urgent need for such a resource. A special grant provided by the SSHRCC will provide Professor Smith with a base for this new start. We know that he can count on your cooperation as he begins to update or renew data.

#### LOBBYING AND REPRESENTATION

Let me try to give you, in a few paragraphs, a sense of our activities in the area of lobbying and representation.

First, the revision of the 1924 Copyright act: like some other organizations in the higher education sector, we have expressed strong reservations concerning the revision process. The Government wishes to have a first series of amendments to the Act adopted before it submits a second series of amendments, late in the Fall of 1987. We are suggesting to the Minister of Communications that she should outline the nature of the second series of amendments now, so that people may judge the ensemble of changes, rather than having to accept blindly the first set of amendments. The SSFC is also monitoring the revision of the Access to Information and Privacy Acts: in spite of the very precise recommendations of the Commons Committee which made a lengthy and exhaustive review of these statutes, the Government appears to have decided not to enact any significant changes. The SSFC, which supported the position taken by the Commons Committee, will continue to press the issue.

We are also making representations on two other issues: the threat of the cancellation of the postal subsidy of second-class mail and the non-discriminatory fiscal treatment of social science research. A decision regarding the postal subsidy is expected in a few weeks. The fiscal treatment of R&D is a much longer term issue, but I hope that our efforts will soon begin to show positive results.

The working groups on the National Science and Technology Policy represent another important part of the Federation's activities. We have been invited by the chair of the group on Social/Cultural Impacts of Science and Technology to collaborate in defining some aspects of the action plan that each of the seven groups must submit to the Council of Ministers of Science and Technology. We are also developing a brief which will be submitted to the working group on Basic Research.

Finally, I sould note that the SSFC was well represented at the Saskatoon Forum on Post-Secondary Education, October 25-28: the President, Past-President, and a few members of the Board of Directors were invited to this major conference. It is too early to say whether there will be any concrete government action as a result of the Forum.

#### PUBLICATIONS

I am pleased to announce the publication of the Directory of Social Science Research Centres and Institutes at Canadian Universities and of the Proceedings of the National Conference on University Research Centres in the Social Sciences and Humanities. Both publications developed out of the March 1987 Conference organized by the Federation. They are published for the SSFC by the University of Ottawa Press.

#### ACTIVITES DE LOBBYING ET DE REPRESENTATION

J'aimerais, en quelques lignes, essayer de vous donner une idée des principales activités de la Fédération dans le domaine du lobbying.

Tout d'abord, la révision de la loi de 1924 sur le Droit d'auteur. La Fédération ainsi que plusieurs autres organismes du secteur de l'enseignement supérieur, s'est opposée au processus de révision proposé par le gouvernement; ce processus exige en effet de la part du public un acte de foi envers le gouvernement, puisqu'on voudrait faire adopter de façon définitive une première série d'amendements, sans dévoiler ce que contiendra la deuxième série d'amendements, qui doit être déposée tard cet automne! Nous avons suggéré à la Ministre responsable de dévoi ler dès maintenant le contenu de la deuxième série d'amendements, afin que l'on puisse porter un jugement éclairé sur l'ensemble du dossier. Dans la même veine, nous surveillons de près la révision de la Loi sur l'accès à l'information: le Gouvernement, malgré les demandes très précises du Comité des Communes qui avait étudié la loi en profondeur, a adopté une position très prudente, pour ne pas dire peureuse, refusant toute modificattion significative. La FCSS, qui avait soutenu les positions adoptées par le Comité des Communes, continuera son lobby sur cette importante question.

Nous continuons aussi à faire des représentations sur deux autres dossiers qui affectent directement les chercheurs 1) La menace de suppression du tarif postal de 2º classe, qui entrainerait des augmentations de coûts dans la distribution des revues et livres; des décisions à ce sujet devraient être annoncées au cours des prochaines semaines. 2) Le traitement non-discriminatoire de la R&D en sciences sociales: il s'agit là d'un problème qui ne peut être réglé rapidement, mais j'espère que les efforts de la FCSS dans ce domaine commenceront bientôt à porter fruit.

La Fédération est également impliquée très activement dans les travaux des groupes chargés d'élaborer le plan de mise en oeuvre de la Politique nationale de la science et de la technologie. Nous travaillons avec deux de ces groupes - le groupe des Impacts socio-culturels de la science, à qui nous avons soumis un Mémoire, et qui nous a invité à participer à l'élaboration de son plan d'action, et le groupe sur la recherche fondamentale, à qui nous soumettrons très prochainement un Mémoire.

En terminant, je tiens à souligner que la Fédération était bien représentée au Colloque national sur l'enseignement postsecondaire, à Saskatoon, fin octobre. Le Président, le Président-sortant et quelques membres de notre Conseil d'administration participaient à cette importante rencontre. Il est encore trop tôt pour savoir si les gouvernements donneront des suites concrètes au Colloque.

## Parliamentary Internships program

## Stages parlementaires

The Canadian Political Science Association, in collaboration with the Speaker of the House of Commons and the House Leaders, announces the competition for the Parliamentary Internships Programme 1988-1989.

For the 1986-1987 year, the Programme's Patrons, each contributing \$15,000 or more, were the Canadian Life and Health Insurance Association, the Insurance Bureau of Canada, the Public Affairs Resource Group Ltd., and Executive Consultants Ltd., while the Social Sciences and Humanities Research Council provided a core administrative grant.

This work-study programme has a threefold aim. It provides back-bench Members of Parliament with highly qualified assistants. It gives university graduates an opportunity to supplement their theoretical knowledge of Parliament with a practical experience of the day to day work of the Members. The graduates of the programme are better able to make a significant contribution of Canadian public life.

The interns! responsibilities include working with Members of the House of Commons, scholarly research, and undertaking study travel.

The internships are open to Canadian citizens who are recent graduates of a Canadian university.

Tenure and income: From September 1988 for a period of 10 months. Estimated \$12,000 plus travel subsidies.

We expect to offer 10 internships for 1988-1989. Completed applications must be received no later than December 31, 1987.

#### Ontario Legislature Internship Program

The 1987-88 Ontario Legislative Interns have begun work in the offices of nine Members of the Legislative Assembly, it was announced recently by Fred Fletcher, the Internship Programme's Academic Director.

The interns and the Members for whom they'll be working for the next four months are:
Bohdana Dutka (Floyd Laughren--NDP, Nickel Belt); Doug Greenwood (Doug Reycraft--Lib., Middlesex); Yvonne Lavallée (Margaret Marland--PC, Mississauga South); Jeff Nankivell (Harry Pelissero--Lib., Lincoln); Vic Nishi (Ruth Grier--NDP, Lakeshore); Alison Pipa (Brad Nixon--Lib., York Mills); Jerald Owczar (Charles Beer--Lib., York North); Laurie Stone (Richard Johnston--NDP, Scarborough West); and Kim Weslak (Rob Runciman--PC, Leeds).

The interns will be working with these Members until the end of February, when they will cross the floor to work for Members on the opposite side of the House. The interns work full time at the Legislature from September through June and are paid a monthly stipend.

Funding for the programme is provided by the Assembly, the Canadian Political Science Association (CPSA) and through private donations. For 1987-88, a stipend for a ninth intern has been provided by the Committee of '94, a women's group devoted to increasing the representation of women in Canadian legislatures. The Committee's stipend offers an opportunity for mature women with an interest in entering the political process.

The intership programme, which was founded in 1976, is administered by a committee consisting of the Academic Director, Assistant Director Graham White of the University of Toronto, and three legislative co-ordinators at Queen's Park: Doug Arnott, John Eichmanis and Ellen Schoenberger.

Interns are selected on the basis of superior academic performance and other achievements by a non-partisan committee appointed by the CPSA. This year's interns come from a variety of backgrounds:

## CANADA'S LEGISLATURE INTERNSHIP PROGRAMS

Each year at a growing number of legislatures across the country, a small group of highly qualified university graduates arrives to begin a unique educational experience. Between 40 and 50 of Canada's most promising graduates are selected from 600 or more applicants to serve as interns in Parliament and five provincial legislatures. The programs themselves vary in both administration and organization, each adapting a structure which is appropriate for its own legislative environment. The Interns will work long, hard hours assisting legislators as well as learning valuable new work skills.

The purpose of this paper is to examine the evolution and current operation of all interns programs and to assess the degree to which the programs have achieved their stated objectives. Our conclusion is that the internship programs have indeed proven to be a notable success, whether measured in terms of the educational benefits to the interns, assistance to Members, or contribution to public understanding (assessed by examining career paths of former interns).

Internships are an outgrowth of the apprenticeship system in the crafts and trades. In the United States, internships, as defined by today's terms, emerged in the 1940's; but it was not until the 1960's that the programs truly blossomed. Canadian internship programs have been most influenced by the program operating in Congress as well as 24 U.S. state legislatures. The American programs are referred to as "fellows programs" thus distinguishing them from a vast array of work-study "internship" programs.

The fellows programs are similar to their Canadian counterparts in that they are only open to graduates; pay a stipend; are awarded through a competitive process, and they are heavily competed for. However, the Canadian programs, while inspired by the American example, have evolved quite independently.

Discussions concerning a proposed internship program for Canada finally culminated in a motion proposed by Alf Hales (M.P. Wellington) on March 10, 1969. After gaining the support of the Canadian Political Science Association (CPSA), the Donner Canadian Foundation, the Speaker and House Leaders, the motion formed the basis for the Parliamentary Internship Program (PIP). Recognizing the merit of such a program, provincial count-erparts were established in Alberta and Quebec (1974); and British Columbia and Ontario (1976). After some years of effort, programs were later established in Manitoba (1985) and Nova Scotia (1986). Their very creation attests to the success of the older programs.

In contrast to the U.S. programs, the Canadian programs stress the benefits to the host institutions and their Members and to society in general as well as to the individual Interns themselves. The emphasis in Canada on service to the Members underscores the fact that

internships are a part of an effort toincrease the policy role of the Private Members. In fact, the Ontario program was part and parcel of a package of parliamentary reforms recommended by the Ontario Commission on the Legislature (Camp Commission) designed to strengthen the role of the Private Member.

Each program has developed a structure which is appropriate to its own legislative environment. The two CPSA sponsored programs (PIP and OLIP) are each administered by a Director appointed by the CPSA Executive Committee for a three year term. The Directors are assisted by legislative officials in the day-to-day operation of the programs but are accountable for financial and policy matters to the CPSA. The PIP Director is assisted by a CPSA appointed Policy Committee of academics and a parliamentary committee representing both the CPSA and the Speaker of the Assembly.

A second model -exemplified by Alberta and B.C.- involves administration by the Speaker of the Assembly. In Alberta, the Speaker is the administrator of the program and the Chairman of the Program's Selection and Advisory Committee. The Committee consists of a representative of the government and opposition caucuses and the Universities of Alberta, Calgary, and Lethbridge. The Executive Assistant to the Speaker handles the day-to-day tasks. Similarly, in British Columbia, the Administrative Assistant to the Speaker administers the daily operations while the Academic Director deals solely with the academic component of the program.

The programs in Nova Scotia and Manitoba represent a third model. In both cases, the Academic Director is the chief operating officer, assisted by the staff in the Speaker's office. However, the Academic Director is responsible to the Assembly through a committee. The Manitoba program is overseen by a steering committee chaired by the Director. It is made up of the Director, the Speaker, and the Clerk of the Assembly and two MLAs representing the political parties. The Committee appoints the Academic Director. In Nova Scotia, the Select Committee on the Procedure of the Legislature appoints the Academic Director.

Special attention must be given to the Quebec program. The Quebec National Assembly was host to a program from 1974-76 and from 1979-86. The first program, funded by the Donner foundation, was highly successful in terms of serving Members and attracting qualified applicants. However, the program which was closely modelled on PIP folded when private funding could not be found. In 1979 four interns were funded under the auspice of the Fondation Jean-Charles Bonenfant, itself publicly funded. With the change in Government in 1985 the Assembly suspended its grant to the Foundation pending a full review of the program.

PIP is the only program which is funded primarily from private sources, and consequently it has a number of financial crises. OLIP originally sought to be privately funded, but was forced to abandon this objective when the program failed to maintain

a 20% level of private funding during the recession. All of the provincial programs with the exception of B.C. have some measure of private support or intend to pursue it. Private funding, therefore, is supplementary to the programs overall budgets. The programs receive the bulk of their funding from the budgets of their respective Assemblies.

The programs, however, are a bargain from any standpoint. For between \$1,250 and \$2,250 (including overhead) per month for each Intern, legislators obtain staff assistance they could not hire for that amount. Indeed, as former MP Cyril Symes has observed, assistants with the qualifications and the motivation of the Interns can only rarely be hired for the full-time salaries that legislators can pay. From an educational standpoint, it would be difficult to maintain Interns in graduate programs for that cost, when fellowships and overhead costs are considered.

The Selection Committees vary, each reflecting its own legislative environment. The criteria for selection, however, along with the actual procedures for the selection of interns are strikingly similar. Personal maturity, academic excellence, interest in and knowledge of parliamentary government are a few of the factors taken into consideration by the Selection Committees. Personal characteristics, such as judgement and capacity to work in a group, play an important role in the final interviews.

The interns work either directly for individual Members (Ottawa, Queen's Park and Quebec City) or for the party caucuses, usually with the research staffs. The Alberta program is a mix of the two. In B.C. and Nova Scotia, the Interns work as researchers in the civil service for 6-8 weeks before moving to the Legislature. This is an adaptation to the short sittings and the relatively inactive committee systems of those two legislatures, but it has the advantage of providing a broader perspective for the Interns.

In the Federal, Ontario, and Alberta programs the Interns "cross the floor" dividing their time equally between the Government and the Opposition, thus ensuring that the Interns gain a true understanding of the roles of both the Government and Opposition. The practice of switching also underscores the nonpartisan and professional nature of the programs. Confidentiality is protected by contractual agreements or oaths of secrecy and there have been very few problems over the years. The B.C., Nova Scotia, and Manitoba interns are assigned to a caucus and they remain with that caucus, the interns have the advantage of gaining yet another pers-pective on the inner workings of the legislature. Nevertheless, both Nova Scotia and Manitoba are exploring the possibility of their interns crossing the floor.

The exact nature of the Interns work depends upon the needs of the Member or caucus.

Often the Interns spend their time writing speeches, briefing notes, constituency letters and newspaper columns, composing background papers on policy issues, drafting Private Members' bills and resolutions and handling queries from constituents. Some have played important roles in committee hearings, acted as co-ordinators for party task forces or helped organize leadership races or relection campaigns. In all of the programs, much of the day-to-day administration of the programs is delegated to the interns themselves.

The academic component of the program is an important one. Many of those associated with the programs believe they are easily the equal of any Masters' program. Indeed, academic credit is often available to Interns, but it must be worked out with individual universities. In Alberta, the Interns themselves serve as guest lecturers in seminars at the participating universities.

The academic structure of the programs has six elements: readings, orientation, diary, faculty, guidance, seminars, and a research paper. Exchange visits, although contingent upon funding available, are of immense educational value. The Interns not only learn about other legislatures but they also gain a new perspective concerning their own legislature. The importance of this cannot be underscored. The research papers are an important part of the program and they constitute one of the legacies left by each group of interns. The papers often deal with subjects neglected or not yet covered by scholars and procedural specialists. The federal program specifies that the papers be of publishable quality and quite a number of papers have in fact been published. The Alberta program has published a volume of its papers and OLIP is planning a similar project Several papers prepared by the Quebec Interns have appeared in Le Bulletin de la Biblio-thèque de l'Assemblée Nationale. The papers constitute a valuable source of material for scholars and others interested in the legislative process as well as comparative provincial politics.

In general, the programs have been outstandingly successful, by almost any measure, in meeting their objectives. All of the program can produce glowing testimonials from Members who have had interns. More revealing, however, is the fact Members continue to apply for Interns in numbers far greater than the available supply- despite the increased resources which have been made available to many legislators. In addition, the continued financial support or the programs form the provincial (including the reinstatement of the Quebec program 1979) is testimony to their popularity and success. The Manitoba legislature has agreed to extend its program from 10-12 months, after less than two years of operation.

The educational benefit to the Interns themselves can perhaps be expressed by Howard Astor, a former federal Intern, now a professor of political science. He stated that "I have learned more about politics during the past 10 months... in the past five years of university study." While the impact of the programs on parliamentary reform is a bit more difficult to discern, there is no doubt that the Interns have served to both strengthen and raise the profile of the Private Member.

By examining the career patterns of past interns, one can also discern that the original goal of creating a body of knowledgeable young people to bridge the wide gulf which exists between academic, business, government, labour and the population at large has been achieved. A 1982 Ontario survey found that virtually all of the program's graduates were either employed in positions where they could apply the knowledge gained in their internship or engaged in study in advanced fields. Former interns include journalists Jeffry Simpson and Christopher Waddell (Globe and Mail); government-business specialists such as Peter McBride of Falconbridge or Tema Frank (whose clients have included the Canadian Bankers Association). The academic world has reaped the benefits of the internship program as interns have completed their studies at Harvard, Oxford, Cambridge and Cornell; at least two interns were Rhodes Scholars. Many decided to remain in academia: Catherine Swinton (associate Dean of Law, University of Toronto), Paul Thomas, (University of Manitoba and Director of the Manitoba Internship Program), David Taras (University of Calgary), and Graham White (University of Toronto). Some interns have pursued careers in the civil service, become researchers for organizations such as labour unions; others have run for public office- two have been elected (as Mayor of Victoria and Judy Wascylcia-Leis, a member of the Manitoba Cabinet to date).

Perhaps the strongest evidence of the success of the internship programs is their survival despite various economic recessions as well as governmental spending restraints. The caucuses and their Members continue to request interns. Professors continue to suggest the program to their best students; former interns highly recommend the program; and students of outstanding quality to apply. Programs that can satisfy students, professors, Members of Parliament and their caucuses, and sponsors must be doing something right.

## In Memorium

#### Crawford Brough Macpherson 1911-1987

Macpherson was born and raised in Toronto. Upon completion of his undergraduate studies in Political Science and Economics at the University of Toronto in 1933, he pursued graduate studies at the University of London, receiving his M.Sc. in Economics in 1935. From that year until his retirement in 1977, he taught at the University of Toronto, Department of Political Science; the continuity of his association with the University being interrupted only for a brief period during World War II. His published work in political theory earned him the higher doctorate of the University of London, the D.Sc. (Econ.) in 1955.

He was President of the Canadian Political Science Association and the Canadian Association of University Teachers. He served on the Executive of the International Political Science Association and chaired for several years the Conference for the Study of Political Thought, a prestigious international political theory society. His service to the University of Toronto included chairing the Presidential Advisory Committee on Undergraduate Education which led to the restructuring of the undergraduate curriculum in the Faculty of Arts and Science in 1966-67.

Macpherson was appointed officer of the Order of Canada in 1976; he was elected Fellow of the Royal Society of Canada and of the Royal Historical Society, England. In 1975, he received the title University Professor at this University.

Visiting professorships, conferences and lecture invitations brought him to many parts of the world: England, Europe, the United States, Latin and Central America, Australia, Japan and the Middle East. He was Visiting Research Fellow, Institute of Advanced Studies, Australian National University; Visiting Professor, Institute of Jerusalem, and a Fellow of Churchill College, Cambridge. He received numerous honorary degrees.

Macpherson's books include: Democracy in Alberta: Social Credit and the Party System; The Political Theory of Possessive Individualism: Hobbes to Locke; The Real World of Democracy, the Massey Lectures; Democratic Theory: Essays in Retrieval; The life and Times of Liberal Democracy; Burke, the Past Masters series; The Rise and Fall of Economic Justice and Other Essays. He edited with an introduction Thomas Hobbes' Leviathan; edited and contributed to Property, Mainstream and Critical Positions; edited with an introduction John Locke's Second Treatise of Government. C.B. Macpherson's works have been translated into German, Spanish, French, Italian, Portuguese, Japanese, Swedish and Danish.

A Memorial Service was held for C.B. Macpherson on 30 September, 1987 at the University of Toronto.

A plenary session of the Canadian Political Science Association's meeting at the Learneds is scheduled for Thursday, June 9 at 1:30. Directly following the Plenary there will be in the Political Theory section, a roundtable on C.B. Macpherson's work.

L'édition dans les sciences sociales atteste clairement d'une réalité gommée ces année-ci: les sciences sociales sont branchées sur le réel, en prise directe sur la vie immédiate. La mutation de la famille, de la modernité et de la paternité, le défi démographique et psycho-social du vieillissement et de la jeunesse, les tendances de l'environnement urbain, ethnique et linguistique, l'évolution des paramètres de la santé et du travail constituent autant de domaines sur lesquels l'édition québécoise en science sociales jettera quelque lumière cette année.

Le programme d'édition de l'Institut québécois de recherche sur la culture (IQRC) est, à ce titre, révélateur des tendances. L'IQRC publiera deux ouvrages sur la famille: Des mères sans alliance, de Renée Dandurand, sur la famille monoparentale, qui a aussi dirigé la parution du numéro 13 de Questions de culture sur les "Nouvelles tendances de la vie familiale". The Computerization of Canadian Political Science

Gernot Köhler/Sheridan College

A survey of Canadian political scientists conducted in February of 1987 shows a number of interesting facts about the computerization of the profession and the actual uses made of computers in everyday professional life. The survey was in the form of a questionnaire which was mailed to the members of the Canadian Poli tical Science Association (non-institutional membership 1,070).

Highlights of the survey:

- 1. Between 1971 and 1987 the share of computer users in the profession increased from 21 percent to an estimated 70 to 86 percent.
- 2. Microcomputers are more widely used than mainframes by a ratio of over 2: 1. Micros are used by 88 percent and mainframes by 40 percent of all computer users. 27 percent
- 3. The major areas of computer application by political scientists are:

#### STUDYING AUSTRALIAN POLITICS IN CANADA

The study of Australia is a growth industry within Canada! On Saturday morning, June 6, approximately 30 people attended a session on "Public Policy Research in Canada and Australia" as part of the annual meeting of the CPSA.

The session was also attended by two distinguished colleagues from Australia who have made the "Canadian-Australian connection" from the opposite direction: Dr. Brian Galligan (Australian National University and President of the Association for Canadian Studies in Australia and New Zealand) and Dr. Ken Wiltshire (University of Queensland, a founder of ACSANZ).

Several important points come out of this gathering. First of all, its success demonstrates a widespread interest in Australia in the Canadian political science discipline (and in related disciplines, since at least one historian and one economist "crashed" the meeting!) In passing, John Courtney reminded the meeting that there appears to be a degree of asymmetry in the relationship between the two countries in "the public sector": Canadian experiences with a wide range of problems and Canadian policies in response to them are often looked at by Australian authorities, but Canadian authorities look to Australia less frequently. Perhaps the Canadian discipline can assist in adjusting this balance.

Secondly, the group indicated its firm desire to establish an on-going network through which political scientists in Canada with interests in Australia can stay in contact with one another and can share matters of mutual interest. One of the subsequent goals of the network will be to take stock of the full extent of research on Australian politics in Canada and the range of political science courses with significant Australian content in Canadian universities.

Thirdly, the possibility of organizing a joint workshop involving the CPSA and the Australasian Political Studies Association (APSA) was raised. This question will be addressed to the CPSA Board by Robert Williams in the near future.

#### NAB SOLICITS PROPOSALS FOR RESEARCH GRANTS

The National Association of Broadcasters has announced that it is seeking proposals for its 1988 Grants for Research in Broadcasting. The deadline is February 1, 1988. The program, now in its 22d year, permits maximum awards of \$5,000 to individual grantees, and approximately four to six are awarded annually. Problem conceptualization, research technique, contribution to the field, and clarity and thoroughness are the criteria by which each proposal is judged. Winners will be announced at the 1988 Broadcast Edition Association Convention in Las Vegas next April.

Governance is being launched to fill a gap in the current literature - namely to provide a forum for both scholars and academics interested in questions of comparative executive politics (including elective, appointive and career members of the executive branch of government), and in the development of better conceptual approaches to questions of structure and organization in the public sector. It is explicitly international and comparative in approach, focusing for example on single country studies only to the extent that these are relevant to the experience of other countries or that they have direct theoretical relevance.

Governance will pay particular attention to the politics of the executive branch of government which is defined as the career civil service, their political "masters" and the variety of relationships between these and other components of the political system including organizations such as nationalized industries.

Governance is edited by Colin Campbell of Georgetown University, and B Guy Peters of the University of Pittsburgh, with the help of an international editorial board. Published quarterly, it will fill a gap in the current literature because it is explicitly comparative and international in its approach.
