The Paradox of the Late Twentieth Century  
International Integration and National Fragmentation

The Berlin Wall has fallen. The Soviet empire is dislocated. The communist world is not the shadow of its former self. But the end of History is not in sight. Far to the contrary.

Strong winds have appeared, and they seem to push our world in opposite directions. Our times are simultaneously those of international economic integration, of a rapprochement between cultures and peoples with regard to customs and ways of life, but also those of multiplying demands, based on identity, that have already started the fragmentation process of a certain number of peculiarly fragile states.

To study this complex phenomenon and to understand its potential consequences for the world at large and for our own country, the Canadian Political Science Association has assembled a prestigious group of scholars from Great Britain, the United States and Canada. We invite you to attend our plenary session, organised by Guy Laforest, chaired by our new president Sylvia Bashevkin, to listen to Professors Jane Jenson, Murray Forsyth, John Kincaid and Kenneth Minogue.

**Professor Murray Forsyth, Director of the Centre for Federal Studies at the University of Leicester**, works in the area of nationalism and comparative politics. He is a central force in the work on federalism of the international Political Science Association's ongoing Workshop on this subject. The Centre of which Professor Forsyth is Director is a member of the International Association of Centres of Research into Federalism. In that context Professor Forsyth has had an important collaboration with the team headed by Professor Ronald Watts of the Institute of Intergovernmental Relations at Queen's University.

**Dr. John Kincaid is a member of the U.S. Advisory Commission on Intergovernmental Relations, Washington, D.C.** Before accepting appointment to the Commission, Professor Kincaid taught at the University of Texas (Austin) and at Johns Hopkins University. Federalism has been the focus of his research. His current work is precisely on the subject of federalism in the face of rapidly developing globalization. Dr. Kincaid is the Editor of one of the most important American political science journals, **PUBLIUS**. Its "champs d'étude" is federalism.

**Professor Kenneth Minogue of The London School of Economics and Political Science** is an internationally renowned specialist in these issues. His book, **NATIONALISM**, has been, or course, unanimously acclaimed. He has recently published outstanding work on nationalism in the former Soviet Union. He also knows well the Canadian reality. In September 1989, for example, he was a central participant at a conference on the thought of the late George Grant - an important scholarly event held at Carleton University and organized by political theorist, Peter Emberley.

Le paradoxe de la fin du vingtième siècle

Intégration internationale et fragmentation nationale

Le mur de Berlin est tombé. L'empire soviétique a éclaté. Le monde communiste s'est fissuré. Mais l'Histoire n'est pas terminée. Bien au contraire.

Des vents violents se sont levés, qui semblent pousser notre monde dans des directions opposées. Nous vivions à la fois à l'heure de l'intégration économique internationale, du rapprochement entre les cultures et les peuples sur les plans des moeurs et des modes de vie, mais aussi à l'heure de la multiplication des revendications identitaires qui ont déjà commencé à accélérer le processus de fragmentation d'un certain nombre d'États fragiles.

Pour étudier ce phénomène complexe et pour en comprendre les conséquences possibles aussi bien pour le monde que pour notre propre pays, l'Association canadienne de science politique a rassemblé un groupe prestigieux d'experts venant des États-Unis, de la Grande-Bretagne et du Canada. Nous vous invitons à venir entendre les professeurs Jane Jenson, Murray Forsyth, John Kincaid et Kenneth Minogue, lors d'une séance plénière organisée par Guy Laforest et animée par notre nouvelle présidente, madame Sylvia Bashevkin.

**Murray Forsyth**, Director, Centre for Federal Studies, Leicester.

Le professeur Forsyth travaille sur le nationalisme et le fédéralisme comparé. Il est un membre important du groupe de travail sur le fédéralisme de l'Association internationale de science politique. Le centre qu'il dirige appartient à l'Association internationale des centres de recherche sur le fédéralisme. À l'intérieur de cette association, le professeur Forsyth a collaboré avec l'équipe du professeur Ronald Watts de l'Institute of Intergovernmental Relations de Queen's University.

**John Kincaid**, Advisory Commission on Intergovernmental Relations.

Le professeur Kincaid a enseigné au Texas (Austin) et à la Johns Hopkins University. Ses travaux portent sur le fédéralisme. Il étudie actuellement la place du fédéralisme à l'heure de la globalisation planétaire. Il est le rédacteur d'une des plus importantes revues américaines de science politique, **PUBLIUS**, une revue d'étude du fédéralisme.

**Kenneth Minogue**, London School of Economics and Political Science.

Le professeur Minogue est un spécialiste de réputation internationale sur la question du nationalisme. Son livre intitulé Nationalism fut unanimement acclamé par la critique. Récemment, le professeur Minogue a publié des travaux remarquables sur les nationalismes dans l'ex-Union soviétique. Il connaît bien la réalité canadienne. En septembre 1989, il a participé à un colloque sur la pensée de George Grant, à Carleton University, organisé par Peter Emberley.
