

#### **COMMITTEES**

As in past years, the interns are assigned to committee work that is both relevant and necessary to the viability, operations, and sustainability of the programme. The interns prepared mandate letters that speak to the strategy, plans, and objectives for their respective committees. The committees have implemented some of their tactics and are well on their way to meeting their objectives. This report features details of the strategies and plans for all committees, and highlights activities undertaken to date.

## **Study Tours Committee**

OLIP has been thrilled to return to all in-person study tours for the 2022-23 programme year! The Study Tours committee has worked hard to facilitate successful study tours to the Parliament of Canada in Ottawa, the Quebec National Assembly in Quebec City, and the Legislative Assembly of the Northwest Territories in Yellowknife. They are currently working hard to plan the two final study tours for the year, when the interns will embark on their journeys to Boston and the United Kingdom. With the help of the administrative team, the study tours committee made contact with the Massachusetts Senate in Boston, and they have very kindly agreed to host our cohort in May of 2023. This is the first time OLIP will be traveling to this destination, and we hope this is something the program can continue doing for years to come.



After hosting the Quebec Interns for a successful visit to Queen's Park in the fall, the OLIP interns are really looking forward to welcoming the Parliamentary Internship Programme cohort to Queen's Park in June.

#### **Social Media Committee**

The Social Media Committee has been very active this year. One priority was to reach a broader audience on Instagram through fun and creative posts. This has included Instagram Takeovers to give a "day in the life" view of working in a Member's office, and using the question and response feature to interact directly with followers. Another priority has been to support the recruitment process for next year's cohort. This committee promoted information sessions through Instagram account and prepared graphics for the recruitment campaign to be posted on all social media channels. The social media committee has paved the way for the next cohort, and we hope to see more online engagement in the future.

#### **Recruitment Committee**



The recruitment efforts of the 2022-2023 Committee have been successful in finding an excellent incoming cohort. As previously noted in the fall report, the OLIP Recruitment Committee has dedicated an extensive amount of time and effort to advertising and hosting several information session for students all over the country, with a particular focus on Ontario universities. As a result, a majority of OLIP applicants either live in the province or are enrolled in an Ontario university. Nonetheless, the committee saw a larger than usual number of OLIP applicants apply from outside of Ontario, some of whom are included in the 2023-2024 cohort.

Between October 2022 and January 2023, the committee planned, executed, and hosted information sessions across Ontario and Canada and virtually to promote OLIP and encourage

applications. Of these, most were conducted in partnership with post-secondary institutions, specific programs or campuses. The information sessions were advertised through the OLIP Instagram and other platforms. In some cases, the sessions were also posted on LinkedIn, Twitter, and Facebook. The committee saw an increase in attendance when they tagged different university clubs, groups, and societies, a tactic often used to broaden the reach of Instagram posts.

This resulted in the receipt of 115 applications. We interviewed 26 applicants and chose 10, all of whom have accepted our offers of employment. We appreciate the diligence and hard work of our panel members.



## Spring 2023 - OLIP Academic Director's Report

Receptions & Alumni Relations Committee



The Receptions & Alumni Relations Committee has had an exciting spring. OLIP recently hosted its Spring Reception on May 10th, and welcomed over 150 guests, including many MPPs as well as the Honourable Elizabeth Dowdeswell, Lieutenant Governor of Ontario. The Speaker of the Legislative Assembly, Hon. Ted Arnott, kindly supported the event and gave remarks. He was followed by Dr. André Lecours, the President of the CPSA, and later by the Beef Farmers of Ontario, the headline sponsor of the event. Other important contributions to OLIP were also recognized during the reception. Todd Decker, the Clerk of the Legislative Assembly, was granted an honorary intern designation for his unwavering support of the programme. We also acknowledged the passing of reporter and previous honorary intern Graham Murray, and thanked his wife Susan Murray for generously donating his extensive library on Ontario politics to OLIP. His legacy will live on through the Graham Murray Memorial Library.

The committee also continued its efforts to strengthen and grow the alumni network and its contribution to the programme. As in years past, the committee has produced a monthly newsletter, organized a successful alumni mentorship program, and arranged for alumni to be featured in the *Queen's Park Insider* magazine. During the Ottawa study tour, alumni were hosted at a pub night, which was well-attended.

#### **Partnership Committee**

The objective of the OLIP Partnership Committee is to maintain and build relationships with current and new partners to raise funds for the operation of the programme. For the 2022-23 year, this committee's goals included renewing all existing sources of contributions, securing four new organizations as partners, and acquiring donations through OLIP's alumni network. To achieve this, the strategy focused on three main outreach areas: existing partners, potential new organizations, and alumni. First, this committee is maintaining relationships with all current partners by arranging check-in meetings as well as meetings with the entire OLIP cohort. Second, the committee will reach out to new potential corporate partners, identified by drawing on contacts from existing OLIP data and other research. Third, this committee will leverage OLIP's extensive alumni network to create a new stream of donations.



So far, the Partnership Committee has arranged meetings with almost all current partners to check in and receive feedback on their relationship with OLIP. We have also sent emails to potential new partners and secured meetings with several organizations.

### **Magazine Committee**

The *Queen's Park Insider* (QPI) magazine aims to reflect both the professional and personal aspects of OLIP, allowing interns to share their experiences during the placements and meetings, as well as our cohort's unique bond. Executing the strategy has involved working very closely with the other committees, particularly the Social Media, Partnership, and Alumni Relations and Receptions committees, which has made it possible to align deliverables with key dates set by these committees. In the Spring 2023 issue of QPI, readers can look forward to the usual elements of the magazine, such as intern biographies, first impressions, MPP placements, and meetings with political leaders, alumni, and partners. It also features a tribute to former OLIP coordinator John Eichmanis, who passed away in December 2022.



### **Meetings Committee**

The meetings committee has facilitated an impressive number of meetings so far with the goal of providing this intern cohort with enriching experiences. Due to the decrease of COVID-19 restrictions, the interns have been lucky enough to schedule a significant amount of site visits and inperson meetings this year. The main objective of the committee is to plan, organize, and facilitate engaging meetings between the OLIP interns and notable individuals, including public servants, politicians, academics, subject matter experts, media personalities and more. This year, we have worked very closely with Partnership, Study Tours, and Alumni Relations Committees to effectively co-ordinate opportunities for the interns as well as to promote the program. Throughout the year, we have engaged in 160 meetings. In the new year, the committee will focus on sending out invitations to provincial politicians as well as scheduling academic sessions.
