Policy on POLCAN2

-Approved on 06.12.14--Amended on 05.12.15 (sections B.5; B.10; D)--Amended on 22.02.17 (section F)-

A - General Statement

The Corporation will not assume a position upon any question of public policy not directly related to the discipline of political science or commit its members to any position thereupon (CPSA Articles of Continuance -#5 of Schedule 2).

B - Acceptable Postings

- 1. Call for papers
- 2. Conferences
- 3. CPSA administrative notices
- 4. Memorials submitted by individuals or departments
 CPSA officers will not typically post memorial notices on behalf of the CPSA but may
 decide, from time to time, to submit a memorial notice for one of its former
 president, prize winners, etc.
- 5. Employment Offers
 - Job advertisements will NOT be included in the *POLCAN2* newsletter. They will be posted on in the *POLCAN2* Web site but available only to members. These job advertisements will be posted as soon as they are received and removed from the site one day after the closing date. However, the newsletter will note when new job opportunities have been posted and state that employment offers are posted until the deadline.
- 6. CPSA Departmental Members' Graduate Programmes
- 7. Opportunities

Any posting that is deemed to present an opportunity for academic development of the CPSA membership may be posted. Such postings may include:

- calls for reviewers,
- calls for submissions,
- job fairs, and
- summer school programmes.
- 8. News and updates from the CJPS.
- 9. An abbreviated version of the following list will be made available on the POLCAN2

Web page.

10. Congratulations for prizes awarded to political scientists.

C - Unacceptable Postings

To avoid favoritism and until further consideration of possible revenue streams from publishers, the following postings will not be permitted on *POLCAN2*:

- new books and journals,
- book launches,
- -new issues of established journals, and
- the table of content of new issues.

This list shall not be made available on the *POLCAN2* Web page.

D - Frequency

The *POLCAN2* newsletter will be circulated once a week on Wednesdays provided there is sufficient content to warrant distribution.

E - POLCAN2 Part of New Membership Package

As new members join CPSA, they will automatically be subscribed to *POLCAN2* as part of their membership package. The CPSA welcome letter to new members will include an optout notification.

F - Format

The color scheme and the photos in the newsletter may be changed periodically. CPSA Statements must include the date of the motions that approved the posting at the bottom of the texts.
